Mr. Salvatore Palazzola, 1264 Muirwood Court, Mr. Buzz Palazzola, 3005 University Drive, and Mr. Dominic Moceri, 3005 University Drive, introduced themselves to the City Council.

Mr. Ed Anzek, Director of Planning/Development, provided a brief history of the item before Council explaining that the applicant had requested rezoning of 5.5 acres at the southwest corner of Hamlin and Livernois Roads from R-3 to RM-1, multi-family zoning to accommodate apartments and townhomes. He explained that, following a hearing before the Planning Commission, that body recommended to deny this rezoning request. However, he did note some issues Staff determined merited further discussion. He stressed that, although this is a rezoning and not a site plan matter, the possibility existed that rezoning to an RM-1 designation may be an opportunity for better control of access on Hamlin Road. Mr. Anzek also suggested that, as the north side of Hamlin Road is an industrial corridor, an RM zoning could be used as a transitional use between the two.

PUBLIC COMMENT:

Mr. Shamil Halabu, 2084 Livernois, stated his opposition to this change to the Master Plan as unwarranted and noted that he would prefer an industrial use to a multi-family development.

Mr. Michael Sinclair, 2040 South Livernois Road, described his home as being of historic significance. He stated that changes to the road would result in his home having to be moved. He suggested that a multi-family development would be incompatible with the historic aspects of the area.

Mr. Fred Kaehler, 2006 Oak Leaf Court, described the "watershed situation" behind his home, expressing concern that drainage from this proposed development would pool in his backyard. He noted there are wetlands in the area to be considered.

Ms. Pat Lemmon-Bartley, 2170 South Livernois, expressed her support for the rezoning.

COUNCIL DISCUSSION:

Council members raised concerns regarding the following:

- * Compatible transition from light industrial.
- * Planning Commission unanimously opposed rezoning.
- * Council cannot consider any site plans, only the possibilities under the new zoning.
- * The possibility of a PUD.
- * The high demand for single-family housing.
- * The need for multi-family housing in this area.
- * Requested zoning is not compatible with existing area developments.
- * Traffic safety issues as they apply to the number of curb cuts.

While Council members Duistermars, Holder and Raschke expressed support for the proposed rezoning, specifically noting staffs' support, they urged the applicant to consider withdrawing their request to return at a later date after considering other options, including a PUD.

Mr. Staran requested time to review the PUD ordinance to determine if it could be applied to this situation.

The applicants addressed the concerns of the Council members and residents as follows:

- * Eventual site plan would improve traffic problems. Specifically, a multi-family development would require only one (1) curb cut, as opposed to multiple curb cuts.
- * The applicants are award-winning developers.
- * Noted several area developments similar to their proposal.
- * Stressed that, rather than showing a proposed site plan, they attempted to show the

possibilities associated with the rezoning.

- * The Master Plan is a guide.
- * There are no wetlands associated with this property.
- * A PUD would require an ordinance text amendment.
- * The applicants are not interested in a "spot" PUD.
- * Development would have a positive impact on neighboring properties.
- * Single-family homes result in a greater demand on City services.

The applicants requested consideration for their request and a vote.

She suggested that, as the Administration and Information Services Committee is responsible for setting the salaries of the Mayor and the Administrative Directors, this appointment could present a conflict of interest.

Mr. Robbins indicated that the Mayor is in her second term in office and, thus, is term limited.

COUNCIL COMMITTEE REPORTS

Mr. Duistermars urged President Dalton to include in an upcoming Council meeting Agenda two (2) issues brought forward by the Public Safety Committee: 1) the Narcotics Enforcement Officer plan and 2) the false alarm issue.

Ms. Raschke, Co-Chairperson of the Public Safety Committed, introduced Andrew Roscoe, Youth Representative, who wished to make a presentation to the Council regarding the need for a Narcotics Enforcement Officer.

Mr. Andrew Roscoe, 1108 Avon Circle East, a Junior at Rochester High School, noting his membership on the Public Safety Committee, gave an impassioned speech noting the ongoing "war on drugs," stressing that this is not only an inner-city problem, but is a problem for suburban schools and suburbs as well. He stressed that "the challenge falls to this Council."

President Dalton praised Mr. Roscoe for his speech and stated he would add the matter to a future Council agenda. He noted that this evening was the first time Council had heard about the false alarm issue.

Mr. Duistermars stressed that the Public Safety Committee, in bringing forward these two issues, was attempting to find ways to offset the cost of more officers through other sources of revenue, as in the case of proposed fines for excessive false alarms.

Mr. Robbins described an issue discussed before the Zoning Board of Appeals regarding mobile trailers used as sales offices for construction sites.

Mr. Staran stated that Mr. Scott Cope, Director of Building/Ordinance Enforcement, had met with him and would be bringing forward proposed ordinance changes that would address Mr. Robbins's issue as well as many others.

Ms. Hill explained that the Administrative and Information Services (AIS) Committee would be bringing forward a new policy for the review of City Council appointed positions. Ms. Hill noted that the AIS Committee hoped to introduce the new procedures for meeting materials distribution to the other Communication Committees in the near future. Ms. Hill also noted that the Older Persons' Commission was in the process of examining its fees for non-residents and asked for patience during this process.

Ms. Holder indicated that the sign ordinance issue regarding sign placement and height would be returning before Council in an upcoming Work Session.

President Dalton announced that a resolution to the Rochester College/Historic Districts issue had been reached resulting in a "win-win" situation for all interested parties.

Mayor Somerville noted a lack of funds available for added sheriff's deputies for the proposed Narcotics Enforcement Officer and false alarm issue. She urged Council to consult Director of Finance Bob Spaman.

Mr. Duistermars suggested having the individual who spoke to the Public Safety Committee regarding the false alarm issue appear before Council. He urged Council to evaluate all the facts in an effort to make an informed decision.
