**SUBJECT:** 2006 Spring and Fall Street Tree Planting

## **REQUEST:**

City Council is requested to authorize the issuance of a blanket purchase order to Michigan Lawn Maintenance, Inc. dba Sherman Nursery Farms of Columbus, Michigan for the 2006 Spring and Fall Street Tree Planting in the amount not to exceed \$150,000.00.

## **REASON FOR PURCHASE:**

The Forestry Division contracts for the planting of street trees and trees for general planting programs by compiling a list of acceptable trees and than requesting proposals on the trees and planting services. Included are shade and ornamental trees that are planted along city roads, in parks and at other city facilities. Most of the trees planted along streets are in new subdivision and are a part of the "Subdivision Tree Planting Program". Under this program, developers of all new subdivisions are required to provide funds for street trees to be planted in front of each home. The Forestry Division oversees the planting operation as each new subdivision nears completion.

A second program (the "Citizen Tree Planting Program") was implemented in 1995, making street trees available to residents or businesses at the city's cost of installation. This program became the current "Cooperative Tree Planting Program" in 1999, when new policy was established authorizing use of the City's Tree Fund to match 50% of the cost of each tree purchased.

Sealed proposals were solicited using the MITN website with Michigan Lawn Maintenance, Inc. dba Sherman Nursery Farms being chosen as the best value for the City.

Note: The Forestry Division has applied for the 2006 Emerald Ash Borer (EAB) tree-planting grant from the MDNR Urban and Forestry Program. If received, this grant would be applied to the purchase of up to 160 cooperative trees. The grant would reimburse up to \$125.00 for cooperative trees planted as replacements for ash lost to EAB. Forestry has also applied for a DTE Energy Company grant to plant up to 24 EAB replacement trees at \$125.00 reimbursement per tree.

### **BUDGET:**

Monies for the purchase of these trees will come from private developer and residents' contributions made into the Tree Funds Escrow accounts (281000 and 283003) along with the private contributions made into the Tree Fund's revenue account 631000. Trees purchased under the Cooperative Tree Progam: fifty-percent of the tree is purchased with monies from the participating resident and fifty-percent is financed with the revenues received in the Tree Fund. Revenues in the Tree Fund are generated from the tree replacement ordinance.

# Subdivision Tree Planting Program (100% funded by developers):

Funds for this program come from developer fees as prescribed by the Subdivision Control Ordinance (paid by developers per lot). This applies to all subdivisions platted since 1979. Funds are held in an escrow account (232.281000) until about 50% of the homes in the sub have been issued Certificates of Occupancy.

# Cooperative Tree Planting Program:

Funds for this program come from two sources, the residents and the City. The residents matching contributions are held in an escrow account (232.283003) for a few months until the tree is planted on the right of way. The City matches the resident's contributions from the Tree Fund Contractual Services account (232.807000) as established by the Tree Conservation Ordinance. This account is funded by payments placed by developers/builders since 1988 into the Tree Fund's revenue account in lieu of planting replacement trees. Monies are paid by developers per the number of trees that are cut down during construction.

Tree Fund monies do not come from taxes and can only be used for tree planting purposes.

Note: The 2005 EAB Tree Replacement Grant will reimburse the Tree Fund in the amount of \$1,250.00 (10 trees at \$125.00 each)

It is recommended that City Council authorize a Blanket Purchase Order for the 2006 Spring and Fall Street Tree Planting to Michigan Lawn Maintenance, Inc. dba Sherman Nursery Farms of Columbus, Michigan in the amount not to exceed \$150,000.00.
