SUBJECT: Concrete Materials

REQUEST:

City Council is requested to authorized the increase of a blanket purchase order to Utica Transit Mix, Sterling Heights, Michigan as primary vendor and Arlington Transit Mix & Masonry Supply, Shelby Township, Michigan, as secondary vendor, for ready mix concrete materials in the amount of \$50,000 for a new not-to-exceed total of \$120,000.

REASON FOR PURCHASE:

The Department of Public Service has increased its concrete program, while decreasing the use of asphalt during 2007. Therefore, an increase to the existing blanket purchase order in the amount of \$50,000 is needed.

Ready mix concrete materials was bid and awarded by City Council in January, 2007 to a primary and secondary vendor. Both vendors are utilized, based on their ability to supply the concrete materials to meet the delivery times required by the department for daily operations.
