**SUBJECT:** Citywide Janitorial Products

### **REQUEST:**

City Council is requested to authorize the issuance of a blanket purchase order for janitorial supplies, paper products, green cleaning products, and other items to Nichols Paper & Supply Co., Rochester Hills, MI 48309, in the total amount not-to-exceed \$90,000.00 through February 28, 2023.

### **REASON FOR PURCHASE:**

The City of Rochester Hills requires the purchase of janitorial supplies, paper products, green cleaning supplies, cleaning equipment and other items for City Hall, Fire Stations, DPS Garage, Van Hoosen Museum, Borden, Bloomer and Spencer Park locations that must be delivered minimally once per month and/or on an as-needed basis.

The Purchasing Division solicited a competitive sealed Request for Proposals for janitorial products through the MITN system. Ten proposals were received. A committee comprising of staff from Facilities evaluated the responses with over 100 products and four responses were deemed to be not in the competitive range as they only proposed on provided less than 10% of the City's needs. From the remaining six proposals, it was determined the response from Nichols Paper & Supply Co. of Rochester Hills, MI was most advantageous for the products. The proposal received from Nichols Paper & Supply was deemed to be the best value to the City based on their proposed methodology of ordering, breadth of products, stocking levels, and fair & reasonable pricing; and is recommended for award.

Nichols Paper & Supply Co. has previously provided janitorial products to the City and performed satisfactory.
