SUBJECT: Labor and Employment Legal Services

REQUEST:

Request for Purchase Authorization for labor and employment legal services, blanket purchase order not-to-exceed \$130,000; Kemp, Klein Law Firm, Troy, Michigan.

REASON FOR PURCHASE:

Thomas L. Boyer of KKUE has provided labor and employment legal services directly to the City of Rochester Hills for over 31 years. His dedication and unique historical perspective continues to add value to his role as the City's principal attorney for labor and legal matters.

Activities for 2007 will include Mr. Boyer's service as the management delegate on the arbitration panel for an Act 312 arbitration filed by the City's Fire Fighter Union. He will also be involved in contract negotiations with ASCME Local #1917, which represents Supervisors and Managers. Major economic issues for arbitration and negotiation include pension and proposed health insurance plan changes consistent with those recently agreed to with AFSCME Local #2491. Research and analysis relative to other major contract issues will be also be addressed.

Other matters anticipated include grievances, administrative and personnel policy matters, as well as ongoing compliance with legislation such as the Fair Labor Standards Act, the Family and Medical Leave Act and the Americans with Disabilities Act.
