SUBJECT: Construction Management Pre-Construction Services for Fire Station 1 HVAC/Roof

Replacement Project and Restroom/Locker Room Renovations Project

REOUEST:

City Council is requested to authorize a blanket purchase order/contract for the City's Construction Management Firm, Auch Construction, Pontiac, Michigan to perform pre-construction services related to the Fire Station 1 HVAC and Roof Replacement Project, along with the Restroom and Locker Room Renovations Project in the amount not-to-exceed \$22,764.00 and further authorize the Mayor to execute an agreement on behalf of the City.

REASON FOR PURCHASE:

The City of Rochester Hills, through the Oakland County Cooperative Program utilize the Construction Management Services agreement that was awarded to Auch Construction to assist with certain projects in which they are able to assist with construction related projects in where the City needs additional expertise and assistance to complete. Auch works in coordination with the City and the selected architectural firm to provide guidance, oversight, attend meetings, bid scopes, schedule and estimating to keep the project on track and provide value engineering, guidance and recommendations to stay within budget as the project is being designed by the architect.

The City has utilized Auch several times over the past few years and has greatly appreciated the relationship and services they have provided. Auch has been involved in many fire station related projects and have a good understanding of their operations which will assist in providing plans to accommodate the roof replacement and HVAC replacement to ensure emergency response and operations are not impacted during this disruption. Once pre-construction services are completed, Auch in partnership with the City's purchasing division will issue the bid to solicit for the appropriate trades to complete the work, and a GMP contract will be brought forward to receive City Council's approval to move forward with the construction portion of the contract.
