NOTICE IS HEREBY GIVEN THAT THE ROCHESTER HILLS CITY COUNCIL, in accordance with the Open Meetings Act, Act 267 of the Public Acts of 1976, will hold a public hearing on Monday, May 2, 2016, at 7:00 p.m., Michigan Time, at the Rochester Hills Municipal Offices, 1000 Rochester Hills Drive, Rochester Hills, Oakland County, Michigan, to consider and determine the necessity of vacating, discontinuing or abolishing the street, alley, public ground or part thereof described as follows:

S. Castell Avenue and Helmand Road (Platted Harrison)

Property located in the southeast quarter of section 15, T.3N., R.11E., City of Rochester Hills, Oakland County, Michigan, more particularly described as:

The portions of S. Castell Avenue and Helmand Road (platted Harrison) rights-of-way commencing at the northwest corner of Lot 6, Block 9 of "C.O. Renshaw Addition to the Village of Rochester", as recorded in L.4 of plats, P.55 O.C.R.; Thence S02° 46′ 56"W, 120.00', to the southwest corner of said Block 9; Thence N84° 13′ 10"E, 145.00', along the southerly line of said Block 9; Thence S02° 46′ 52"W, 50.56′, to the northerly line of Block 10 of said "C.O. Renshaw Addition to the Village of Rochester"; Thence S84° 13′ 10"W. 170.28′, along the northerly line of said Block 10 and continuing to the northsouth ¼ section; Thence N02° 46′ 56"E, 149.33′, along said ¼ line; Thence N47° 46′ 56"E, 35.36′ to the point of beginning. Containing 11498.645 SF / 0.264 ACRES

The Rochester Hills City Council hereby declares it has, by resolution dated April 11, 2016, deemed it advisable and has declared its intention to vacate, discontinue or abolish the above described street, alley, public ground or part thereof.
