### **REQUEST:**

City Council is requested to authorize a blanket purchase order/contract for construction engineering (CE) services for the Barclay Circle Rehabilitation Project to OHM Advisors, Livonia, Michigan in a not-to-exceed amount of \$400,000.00.

## **REASON FOR PURCHASE:**

The City received bids for the Barclay Circle Rehabilitation Project and based on 2024 department workload, the Department of Public Services has determined an engineering consultant should be used for this project to supplement City staff with construction engineering services.

Staff recommends OHM Advisors to perform the construction engineering services to the City. The attached proposal describes the scope of services and corresponding expense to complete the work. OHM Advisors is one of the City's selected on-call professional engineering firms and assisted in the design and specifications of this project
