To Whom It May Concern:

The City of Rochester Hills has received applications to vacate the public's interest in the 30 foot west  $\frac{1}{2}$  of platted Samuel Avenue right-of-way abutting the east side of the residence at 1644 Alsdorf Avenue; the 30 foot west  $\frac{1}{2}$  of platted Samuel Avenue right-of-way abutting the east side of 1649 Gilsam Avenue, and the 30 foot east  $\frac{1}{2}$  of Samuel Avenue right-of-way abutting the west side of 1621 Gilsam Avenue. The applications were reviewed and approved by the Department of Public Services. In order to avoid having a landlocked portion of Samuel Avenue right-of-way remaining, the City of Rochester Hills will be vacating the public's interest in the 30 foot  $\frac{1}{2}$  width right-of-way abutting the Northbrooke Subdivision's Commons area on the east side and the 30 foot  $\frac{1}{2}$  width right-of-way abutting Meadow Creek II Condominium's Commons area on the west side. This was presented to the City Council on February 7, 2022. City Council has tentatively approved the vacation request, and scheduled a Public Hearing for March 21, 2022 at its regular City Council Meeting.
