## Comments / Section 5:

American Video Transfer believes that sound deadening is different than sound absorption and is significantly more difficult to achieve especially when applying to already built rooms. Almost all effective sound deadening would require modifications of existing HVAC and ceilings and potentially walls. This in turn require the appropriate contractors with the proper licensing. And unless a sound engineer is involved, sound deadening is subjective. Applying things like extra insulation or dense materials may have only a minimal effect and can not be guaranteed to have any effect unless a sound engineer takes acoustical readings and specifies the materials and installation method. As such, at this time, American Video Transfer is not providing a quote for any options for sound deadening.

Note that in the near future, American Video Transfer may be able to provide a "sound masking" system that is currently being testing in the Oakland County Sheriff's substation in Orion Township. Sound Masking is when a speaker (in the ceiling) playing white noise is installed in each of the interview rooms. The intent is to mask the voices that may come outside of a given room or from room to room. The slight white noise sound in the background makes it hard to hear the noise on the other side of the wall. The challenge with this method in an interview room it that it can also create added noise opt the recording and perhaps make it more difficult to hear the interview recording. At Orion Township, American Video Transfer is attempt to mitigate the challenge by using wall microphones instead of ceiling microphones. American Video Transfer is testing this at Orion Township and getting feedback from the end users after the product is fully installed at the substation.
