SUBJECT: Oakland County Sheriff's Office Law Enforcement Agreement for FY 2025-2027 Update

REQUEST:

We request that City Council consider and authorize the Mayor to execute an Amendment to the three-year Law Enforcement Services Agreement with the Oakland County Sheriff's Office (OCSO) for FY 2025-2027.

REASON FOR PURCHASE:

The Oakland County Board of Commissioners has approved an Amendment to the previously 2025-2027 Law Enforcement Services Agreement to Oakland County communities who utilize the OCSO for patrol services to defer 4.0% of the annual 2025 cost in Year #1 of the contract (retroactive to January 1, 2025), and defer this sum until 2027, or Year #3 of the contract, with no additional interest.

For the City of Rochester Hills, this would decrease / defer FY 2025 OCSO costs by (\$475,320) with a corresponding increase in OCSO costs in FY 2027 of the same +\$475,320 deferred from FY 2025. The additional \$475,320 would continued to be invested by the City and could potentially earn an additional \$40,000 over the 2-year term.

If approved by City Council, a FY 2025 2nd Quarter Budget Amendment will be prepared to decrease the Contractual Police Services account in the Police Fund by (\$475,320). The deferred costs in FY 2027 will be incorporated into the forthcoming FY 2026-2028 Proposed Budget and other long-term financial plans.
