Pending request to transfer 7,000 shares of stock from William Davidson to D Management Group, L.L.C.

Dear Detective Damiani:

Thank you for taking time to speak with me this afternoon. As we discussed, PSE filed a request in April for Liquor Control Commission ("LCC") approval of a stock transfer. William Davidson, the sole stockholder of PSE, transferred 60% of his PSE shares to D Management Group, L.L.C., a Michigan limited liability company of which Mr. Davidson is the sole member.

Because the stock transfer was from Mr. Davidson to a limited liability company that Mr. Davidson is the sole member of, the LCC determined that an LCC Enforcement Division investigation was not necessary or warranted. As illustrated on the attached chart, the ultimate controlling person before the stock transfer was Mr. Davidson; he retained control after the transfer.

An Auburn Hills Police Department Report and local resolutions from the City of Auburn Hills, the City of Rochester Hills, and Independence Township are, nevertheless, required. (Only one Police Report is required and the LCC selected your department because The Palace generates more sales of alcoholic beverages than do Meadowbrook and DTE Energy Theater.)

My understanding is that there are no fingerprinting requirements inasmuch as Mr. Davidson has been fully investigated in the past. If there is anything else you require in order to complete your report, please let me know and we will quickly follow up.


