## **PUBLIC COMMENT**

**Ms. Melinda Hill,** 1481 Mill Race, thanked the Planning Department and the Administration for their time and effort in assisting the Historic Districts Commission Community Outreach. **Mr. Lee Zendel**, 1575 Dutton Road, commented that tuition reimbursement in the workplace keeps workers loyal.

## **LEGISLATIVE & ADMINISTRATIVE COMMENTS**

**Mr.** Ambrozaitis stated he attended the Master Thoroughfare Plan Meeting, which included input from residents on aspects of the Plan. He thanked all of the men and women who have served in the military for our Country.

**Mr. Duistermars** asked for remembrance of fallen veterans during this Memorial Day Holiday. He stated we would not have the freedoms that we enjoy today if it were not for the sacrifices that were made on the battlefields.

Ms. Raschke asked residents to take a moment to give thanks to the Armed Forces.

Mayor Barnett noted the following information and schedule of current events:

- 1) The City of Auburn Hills voted to keep the current speed limit of 35 mph on Tienken Road, even though the professional study showed the preferred speed limit was 40 mph.
- 2) Monday, May 29, 2007 Memorial Day Parade beginning at 9:00 a.m. at Mt. Avon Cemetery. The parade will conclude with a ceremony at Veterans Point.
- 3) Vintage Baseball Game The Rochester City Council and Rochester Hills City Council verses the Grangers Saturday, at 1:00 p.m. during the Heritage Festival.
- 4) The City's Neighborhood Beautification Program, which is sponsored by local businesses such as Bordines and Papa Joe's, was created to recognize subdivisions improvements to the common areas and entrances. Local businesses including Bordines and Papa Joe's, have donated prizes.

Mary Schultz, 1208 Marseille Court, gave heartfelt thanks to her neighbors Carol Widger, Josh Simpson, and Ian Taber who saved her from her burning house.

**Mayor Barnett** introduced Carol Widger, Josh Simpson, and Ian Taber; then read the following proclamation issued to each of the brave individuals:

WHEREAS, On the night of April 12, Carol Widger was not able to sleep and was working late into the evening; and

**WHEREAS,** While Carol was in her basement, she heard a neighbor's smoke alarm detector buzzing for what seemed like quite a long time; and

WHEREAS, Even though it was late, Carol decided to check on her next-door neighbor to make sure everything was all right; and

WHEREAS, Upon arriving, Carol saw flames and smoke in Mary's kitchen window; and

**WHEREAS**, After knocking on Mary's door, Carol ran home, called 911, and then proceeded to neighbor Josh Simpson's door, where she knocked and shouted for help.

**WHEREAS,** Josh and Ian saw flames and smoke through Mary's kitchen window and without hesitation Ian immediately broke down the door and Josh was able to evacuate Mary to safety. Once outside, Josh heard the reassuring sound of the emergency vehicle sirens.

**NOW, THEREFORE, BE IT KNOWN,** that the Mayor and City Council of Rochester Hills hereby recognize Carol Widger, Josh Simpson and Ian Taber for their outstanding act of heroism in helping to save the life of Mary Schultz.

**Mayor Barnett** introduced Deputy James Zoedak and recognized his heroic efforts, along with Deputy Keith Hess, who could not be in attendance at this meeting. The two Deputies rescued a mother and her children from their home to prevent them from being harmed by a house fire. Mayor Barnett read the following proclamation to honor their heroic efforts:

On April 12, 2007, at approximately 11:30 PM a structure fire broke out at 1208 Marseille Court in the City of Rochester Hills. Homeowner Mary Schultz was unconscious in the home at the time. Neighbor Carol Widger heard Mary's fire alarm going off and discovered that there was a fire in the kitchen area of Mary's home. Carol attempted to gain entry but was unable to and immediately called 911. Carol alerted neighbor Josh Simpson, who with his friend lan Taber, was able to force entry into Mary's home where they found her unconscious at the kitchen table. Josh and lan were able to evacuate Mary from her flame and smoke filled home.

While fire personnel were working to extinguish the fire, Deputy James Zoedak and Deputy Keith Hess began a door-to-door canvass of the connecting homes in case the fire and/or smoke spread. When they did not get an answer at one home, Deputies Zoedak and Hess kicked in the door and evacuated the homeowner and her two children.

WHEREAS, Deputies Keith Hess and James Zoedak put their personal safety aside to help residents in danger; and

**WHEREAS,** by performing a door-to-door canvass, Deputies Hess and Zoedak were able to make sure that fire personnel were able to concentrate on extinguishing the fire, thus keeping damage contained to one home.

**NOW, THEREFORE, BE IT KNOWN,** that the Mayor and City Council of Rochester Hills hereby recognize Deputies Keith Hess and James Zoedak for their valor in their efforts to help keep residents safe during an emergency situation.

Presentation on the Road Dust Control Program, Roger Rousse, Director of DPS/Engineering, presenter.

**Mr. Roger Rousse**, Director of DPS/Engineering, gave a presentation on the Road Dust Control Program. The following is a synopsis of that presentation:

#### OPERATIONAL APPROACH TO CONTROLLING DUST

- \* Dust Control Program has changed over the past few years due to financial constraints.
- \* In 2003 the dust control program was revised to match the frequency and timetable of the dust control program of the Road Commission for Oakland County (RCOC).

#### HISTORICAL CHLORIDE EXPENDITURES

- \* 2002 \$80,409
- \* 2003 \$68,448
- \* 2004 \$60,895
- \* 2005 \$57,742
- \*2006 \$58,189 includes Mayor Barnett's requested additional spot treatments of worst areas
- \* 2007 \$60,000 budgeted with additional funding being requested by the Administration

## **TODAY'S SITUATION**

- \* Multiple years of applications created a residual of chloride that lasted through last summer under minimal application rates. (1000 gallons per mile)
- \* Chloride residuals are now depleted, creating dust migration under traffic and windy weather.
- \* The Spring 2007 weather has produced unusual periods of dry, windy weather further aggravating the dust conditions.

#### CHLORIDE APPLICATION RATES

- \* Prior years chloride applications were at 2000 gallons per mile with a concentration of 35% chloride. (RCOC uses 23% and 11% chloride).
- \* Current applications are applied at 1000 gallons per mile at the same 35% concentration.
- \* It was generally assumed that a solution to the funding crisis would be found and service levels would be improved.

#### GRAVEL ROAD MAINTENANCE COST

- \* Records of local road maintenance costs indicate that in 2006 Rochester Hills paid 4.3 times more to maintain a mile of gravel road than a paved road. This ratio has been higher in previous years.
- \* Roads are graded on average of eight times per year.
- \* The process includes ditching, grading, chloride and gravel.

#### RECOMMENDATION

- \* Classify roads into three categories; local through streets, local dead end streets and County local roads.
- \* Apply four applications at 1500 gallons per mile to local collector streets and four applications of 1000 gallons per mile to dead end streets.
- \* RCOC application rates for County roads, 2000 gallons per mile at 23% four times per year. Livernois, Dutton, Winkler Mill and Mead.

#### OPTIONS FOR COUNCIL CONSIDERATION

- \* Utilize the \$25,000 that was budgeted for the Sidewalk Repair Program to increase the amount of chloride applied to local gravel roads.
- \* Create Special Assessment Districts for service improvements up and above the basis service level. A typical 1/2 mile road with 100-foot lots would cost each homeowner less than \$50 per application to grade and apply chloride.
- \* Utilize other budgetary allowances to pay for additional chloride applications: such as the \$11,000 designated for tree stump removal.
- Ms. Raschke stated she would like to see the chloride applied immediately after the road is graded.
- **Mr. Rousse** explained the challenges the City faces in trying to apply chloride immediately after a road is graded. He further explained the City purchases the chloride in bulk and needs to apply it within a one- week time frame.
- **Ms. Raschke** informed Council that the Oakland County Road Commission applies chloride to the road immediately after the road is graded.
- *Mr. Rousse* stated he would look for possibilities to improve the process and would discuss this issue with residents.

#### **PUBLIC COMMENT**

- **Ms. Melinda Hill**, 1481 Mill Race, inquired as to why the City was fully funding the Road Dust Control Program as she feels the City does not have the money in the Road Fund to do so. She asked if residents would control their speed on gravel roads, as that would prevent the formation of excess dust.
- *Mr.* Lee Zendel, 1575 Dutton Road, questioned Mr. Rousse regarding two areas on the Dutton Road pathway that are hazardous, and have not been repaired.
- Mr. Walter Johnson, 338 Greenwood Street, stated the dust on Greenwood Street is unbearable creating a health hazard. He emphasized to Council that they should fully

fund this project.

#### **COUNCIL DISCUSSION**

**Mr. Rousse** responded to Mr. Zendel's question that the City does have the Dutton Road pathway on their list for repair.

**Mr. Yalamanchi** questioned since the City incurs costs every year on the gravel roads, has there been any discussion to cover the roads with asphalt.

Mr. Rousse stated residents on three gravel roads have expressed a desire to have their road paved. He further stated the City designed Greenwood as one of the roads to be paved. He advised that the program was suspended when the budget was reduced. Mr. Rousse further advised the City prepared cost estimates for the paving of the roads, but the residents would not support the costs. He stated there were variations in percentages He indicated no monies are appropriated for Special Assessment Districts (SAD); however an SAD is a worthwhile program.

*Mr. Yalamanchi* complimented Mr. Rousse and his staff on the work they have done on local roads in spite of budget restraints.

**Mr. Hooper** stated that he had met with the residents from Greenwood Street, and he supports funding the Road Dust Control Program.

**Mr.** Ambrozaitis inquired as to the probability of purchasing a tanker truck for the purpose of the City having its own vehicle to apply chloride.

Mayor Barnett gave two options for Council to consider offering the residents:

- 1) Keep the current program.
- 2) Have the residents decide between a \$10,000 SAD to pave the street, and a \$50 SAD to maintain the road.

He stated the Administration was not trying to direct Council away from the Sidewalk Program or towards SAD's, but rather provide options for Council to discuss. He commented that the "one size fits all" approach that the City has had in the past is not the best approach at this time. He advised staff is in the process of dividing graveled streets into categories and looking at traffic counts to find the best way to use the Dust Control Program Fund.

President Rosen inquired of Mayor Barnett what Council was being asked to do.

**Mayor Barnett** replied that this item was in response to complaints that the Administration has received over the past 14 to 21 days. He offered the following three options:

- 1) The City would absorb the cost.
- 2) Residents would absorb the cost over a basic level of service.
- 3) Council would take this information under advisement and discuss it during the 2008 budget discussions.

**Mr. Hooper** stated that dust control on Greenwood Street is a quality of life issue and that it is the City's obligation for the public health, safety, and welfare for the residents of this street to increase chloride applications. He further stated that he supports 1500 gallons of chloride to be placed on gravel streets. He noted that Crestline Street has 50% more traffic than Sheldon Road, and thus should have more applications of chloride. He supported

directing the Administration to re-direct funds and put this Dust Control Program into effect as soon as possible.

Mr. Yalamanchi requested a Work Session to discuss the possibility of paving gravel roads.

**Mr. Rousse** stated that in the past chloride was placed on all of the gravel roads in the entire City. He informed that the previous year he began doing spot treatments to severe problematic areas, increasing the cost of chloride. He stated the added chloride applications would address the impaired areas of certain roads if the \$85,000 were approved.

**President Rosen** stated that neglecting maintenance on gravel roads had the potential of having a worse affect than neglecting maintenance on paved roads. He further stated paved roads can go for longer periods of time without doing any type of maintenance, and the road is still passable. He commented that he supports maintenance for gravel roads and will schedule a Work Session to discuss paving gravel roads within the City.

**Mr. Lee Zendel**, 1575 Dutton Road, questioned **Mr. John Staran**, City Attorney, if a property owner does not want to sell to the Green Space Advisory Board (GSAB), does the City have the right to condemn it through Eminent Domain.

Mr. Derek Delacourt, Deputy Director of Planning, asked Council for an increase in the STS Consultants contract for monitoring the Brownfield Development remediation work at Adams and Hamlin. He explained this was an extension to the original request of \$20,000 brought before Council for approval. He stated the Consent Judgment allows the City to employ their own staff to monitor the work throughout the remediation. He advised Mr. Jim Anderson, Associate Scientist, STS Consultants prepared a proposal for the project that contained the following information:

- \* Start date
- \* Number of staff needed at the sight
- \* Number of areas
- \* Number of crews needed
- \* The possibility of splitting actual material samples to send to independent labs for analysis.

He stated the cost estimate from STS Consultants included the following three components:

- 1) The absolute known investigation that is going to take place on the sight as part of the first phase and the monitoring that STS Consultants is proposing would cost \$42,000.
- 2) The cost to monitor additional items if required by the Michigan Department of Environmental Quality as identified by the 381 Work Plan is \$31,000.
- 3) The cost of splitting 20% of the material and having it independently analyzed by the City's consultants is \$9,000.

He advised the final Reimbursement Agreement, upon approval of the Brownfield Development Plan and the 381 Work Plan, is negotiable up to a maximum \$75,000 per year. He further advised that when the second component of STS Consultants' cost estimate (\$31,000) was depleted, he would return to Council and request a Budget Amendment.

**Mr.** Ambrozaitis stated he was regretful having to spend the money but wanted to be sure that the health and welfare of the residents of Rochester Hills were protected.

**Ms.** Raschke commented that the problems with the dumpsites started many years prior to Rochester Hills becoming a City.

A motion was made by Yalamanchi, seconded by Raschke, that this matter be Adopted by Resolution.
