**SUBJECT:** Geotechnical Engineering/Materials Testing

## **REQUEST:**

It is requested that a blanket purchase order/contract be authorized for geotechnical engineering, construction inspection and materials testing services to Testing Engineers and Consultants, Inc., Troy, Michigan in the amount not-to-exceed \$113,340.00 through 12/31/2010 with an option to renew for two (2) additional years.

## **REASON FOR PURCHASE:**

Geotechnical engineering is utilized by the Department of Public Service for public work projects and construction inspection and material testing services on both public and private development projects.

Request for Proposals were solicited and 9 proposals were received. An evaluation team consisting of Roger Moore, Paul Shumejko, Tracey Balint, Kim Murphey and Jean Farris reviewed and evaluated the proposals. Testing Engineers and Consultants, Inc. was selected as the best qualified, as well as a good value for the City. The firm brings a well-rounded and trained staff with an enhanced scope of services and resources provided by a single company at competitive pricing. References from local communities with comparable services were very positive.

Some of this year's projects include the 2010 Concrete Slab Replacement Program, Asphalt Road Rehabilitation Program, Pathway Rehabilitation Program and South Boulevard Pathway Construction Project all of which will require using geotechnical and material testing services. In addition, the services are utilized for private development projects as needed.
