PURPOSE:

Authorization of contract award for yard maintenance services for the 2004-2005 Community Development Block Grant (CDBG) Home Chore Program to Advanced Service 1, Inc., Sterling Heights, Michigan in the amount not-to-exceed \$20,000 or to the extent that CDBG funds are available.

DISCUSSION:

The Community Development Block Grant Home Chore Program in Rochester Hills provides yard maintenance services to income qualified resident 62 years of age and older and handicapped residents for a spring and a fall clean up. This year's program will continue to be administered by the Older Persons Commission (OPC) as in past years. The estimated funds required for the Fall 2004 and Spring 2005 clean up services is \$20,000.

Competitive sealed bids were solicited. The lowest bid, submitted by Glenn Lawn Services, Detroit, Michigan, was withdrawn by the bidder. Advanced Service 1, Inc. submitted the second lowest, responsive responsible bid. Past experience in working with Advanced Service 1, Inc in conjunction with the Community Development Block Grant Home Chore Program has been very positive.
