Historic Districts Study Committee – 1 two-year term, ending 12/31/06


Older Persons Commission – 2 three-year terms, ending 12/31/07

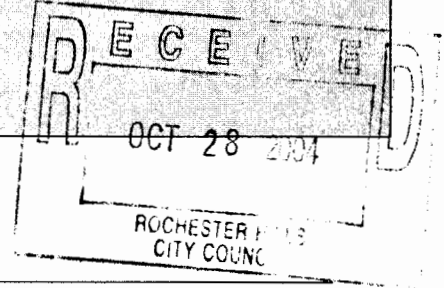
