SUBJECT: Mobile Column Lift Hoist System

REQUEST:

Request for purchase authorization for Mobile Column Lift Hoist System from CTT Equipment, LLC, Midland, Michigan in the amount of \$38,605.00.

REASON FOR PURCHASE:

On April 18, 2013, the City was notified its Competitive Grant Assistance Program (CGAP) Application was approved for funding. The CGAP grant is for the Inter-Local Shared Services Agreement for fleet services between the City of Rochester Hills and the Road Commission for Oakland County (RCOC) for the upgrade of the RTA Fleet Management System and a Mobile Column Lift Hoist System. City Council adopted a resolution authorizing participation in the proposed project on May 6, 2013.

On August 13, 2013, the City of Farmington Hills received bids for Mobile Hoist Columns, awarding to CTT Equipment, LLC, Midland, Michigan as the lowest, responsive and responsible bidder. The bid award was extended to the City of Rochester Hills as a member of the MITN Purchasing Cooperative.

The City's purchase of a complete Mobile Column Lift Hoist System includes lift columns with fork truck pockets, support stands and a cross beam in the amount of \$38,605.00. This equipment is completely mobile, battery powered, and can be used on any flat surface in the fleet maintenance area, parking garage or in outdoor parking lots. The lift system will provide additional flexibility and the ability to lift and service additional vehicles simultaneously.
