SUBJECT: Installation of Electrical Feed and EV Charging Stations

REQUEST:

City Council is requested to authorize a blanket purchase order/contract for installation of the electrical feed and electric vehicle charging stations at City Hall in the secured parking area to F.H. Paschen, Chicago, IL in the amount of \$57,096.96 with a 10% project contingency in the amount of \$5709.69 for a total not-to-exceed project amount of \$62,806.65

REASON FOR PURCHASE:

With the addition of electric vehicles to the City's fleet, there is need to install two (2) electric vehicle (EV) charging stations at City Hall for the operation of the vehicles. The City purchased the EV charging stations with grant money in the past year, and in order to install them, needs to have an electrical feed ran to where the EV charging stations are to be mounted in the parking compound along the wall. The power feed has to be ran from a nearby transformer, with a dedicated EV service line and installation of a meter from DTE. The price above is inclusive of all required engineered drawings, labor, materials, services, permits, etc. for a complete project.

F.H. Paschen is one of the City's selected on-call as needed Job Order Contractors for General Construction, Mechanical, Electrical and Plumbing Services. In reviewing the needs for this project, F.H. Paschen was selected based on their capacity and experience, and is recommending award to them.
