REQUEST:

City Council is requested to authorize a contract/blanket purchase order for the Drexelgate Parkway and Rochester Knoll Subdivision Water Main Replacement Project to Bidigare Contractors, Plymouth, Michigan, in the amount of \$4,070,692.00 with a 10% project contingency of \$407,069.20 for a total not-to-exceed project amount of \$4,477,761.20 and further authorizes the Mayor to execute an agreement on behalf of the City.

REASON FOR PURCHASE:

The Drexelgate Parkway and Rochester Knoll Subdivision water main replacement project is being completed because of the age and material of the water main. The Scope of Work includes the replacement of approximately 16,200 LFT of 6-inch, 8-inch and 12-inch asbestos cement (AC) water main with 10-inch & 12-inch high density polyethylene pipe (HDPE) pipe via the pre-chlorinated pipe bursting method. The Drexelgate water main replacement project was added this year due to the Drexelgate Road Diet and Pathway project being constructed this year.

The City's Purchasing Division issued bids utilizing the MITN system with three (3) bid responses received. Of the responses received, Bidigare Contractors was the lowest, responsive, responsible bidder and award is recommended to them for completion of this project.
