### OPTION 1 - STATUS QUO

*Now, Therefore, Be It Resolved* that the Administration & Information Services Committee recommends to City Council that the rate of pay for the Boards and Commissions for the Fiscal Year 2006 Budget remain the same as 2005 and be set at Seventy-Five Dollars (\$75.00) for the Chairperson, and Sixty-Five Dollars (\$65.00) for the Members per meeting.
