## NOTICE OF PUBLIC MEETING FOR REQUEST FOR SITE PLAN APPROVAL AND TREE REMOVAL PERMIT CITY COUNCIL

## TO ROCHESTER HILLS RESIDENTS:

NOTICE IS HEREBY GIVEN THAT THE CITY OF ROCHESTER HILLS CITY COUNCIL will conduct a Public Meeting per the April 3, 2003 Consent Judgment and the May 26, 2005 Stipulation and Order to Reinstate Consent Judgment of April 3, 2003 and for Amendment of Consent Judgment, Case No. 02-046199-AW concerning the development and use of property located north of Adams Rd. and south and west of M-59 to consider the site plan request described below. Further, pursuant to the Tree Conservation Ordinance, Chapter 126, Article III, of the Code of Ordinances of the City of Rochester Hills, Oakland County, Michigan, this notice shall also serve as a minimum of seven days' notice to all adjacent property owners regarding the request for a Tree Removal Permit as described below.

**LOCATION:** Parcel No. 15-30-302-031, located on the south side of Adams Rd., between Forester Blvd. and Marketplace Cr., zoned I Industrial (Project No. JNRNB2022-0012)

**REQUEST:** Tree Removal Permit. Per Section 126-326 Permit Required, a request to remove nineteen (19) regulated trees with seventeen (17) replacement trees proposed in combination with a 4" tree credit being utilized.

**REQUEST: Site Plan Approval.** Per Section 138-2.200 Site Plan Review and the consent judgment noted above, a request for site plan approval of the Whitewater car wash site plan.
