

2009 CANADA GOOSE  
NEST DESTRUCTION APPLICATION

**APPLICANT RESPONSIBILITY:**

Permits for nest destruction will be based on the conditions and requirements stipulated in the Information Sheet on Canada Goose Nest Destruction Program for S.E. Michigan.

A representative from each site **must attend or previously has attended a mandatory training session** before a permit will be issued.

**APPLICATION IS REQUIRED ANNUALLY TO PARTICIPATE IN THE PROGRAM.**

**ALL APPLICATIONS MUST BE RECEIVED BY APRIL 1, 2009**

A MDNR permit is required to participate in any goose nest destruction activity.

**APPLICANT MUST CHECK ONE OF THE BOXES BELOW**

- Resolution:** Applicant has a resolution approved by the local governmental agency (township, city, etc) which represents the property owners on the subject lake/water/site. **Copy attached.**
- Petition:** Applicant has a signed petition that represents at least 70% of the lakeshore property owners giving approval to conduct the nest destruction on the site listed below. The petition submitted will be valid for a 5-year period, though the applicant **must apply annually** for the program. **Copy of signed petition must be on file with DNR.**
- Business:** Applicant is a commercial institution, or other such entity such as Apartments, Condos, University, Park, or any other type of business.
- Sole Owner:** Applicant is an individual with sole ownership of all lands surrounding the subject lake/body of water.
- Single property:** Applicant is an individual who does NOT have sole ownership or control of the subject lake/body of water/site, but wishes to destroy nests located only on their own property.
