**SUBJECT:** Creation of a Citizens Pathway Technical Review Committee

---

City Council at its regular work session of October 3, 2007 agreed to establish a Citizens Pathway Technical Review Committee for the purpose of identifying pathway projects and presenting their recommendations to City Council.

The following information is being provided to outline what needs to be discussed/identified in forming a committee. I have placed language under each section, based on our discussions at the October 3, 2007 Work Session.

Under Article VII, Section .02 of the Rules of Procedure, it states that Committees shall be established by Council resolution setting for the following:

- 1) Purpose and Charge
  - a. Charge/responsibility of the Committee.  
*Review pathway construction and major rehabilitation projects and recommend priorities to City Council. Review and recommend major pathway policies to City Council such as: Pathway Construction Standards; Compliance with Other Requirements; and the goal of having a contiguous pathway on at least one side of all major arteries.*
  - b. Expected results including, but not limited to, time line.  
*Provide recommendations to City Council, as appropriate, and may exist throughout the life of the current Pathway Millage which was enacted in 2006 and continues through 2015.*
- 2) Membership and selection, including number of members, solicitation of members and qualifications of members.
  - b. Each committee shall include at least two (2) and not more than three (3) Council Members.  
*Two (2) Council Members, and one (1) Planning Commission Member*

- c. Committees may include citizen members which shall be appointed by Council.  
*Seven (7) Citizen Representatives nominated by the Mayor and appointed by Council.*
- d. Committees may include Administrative Staff Members which shall be appointed by the Mayor.  
*As appropriate*
- e. Committees may include one (1) Rochester Hills Government Youth Council (RHGYC) Representative selected by the Youth Council  
*One (1) Youth Council Member*
- e. Term of appointment, where appropriate  
*The term shall be for one year, with the first to expire December 12, 2007. (...or the first to expire December of 2008)*
