The City of Rochester Hills City Council will be making nominations at the regular City Council meeting on December 7, 2020 to the following Boards/Commissions/Committees:

---

**Building Authority**

**To fill one (1) vacant 6-year term ending December 31, 2026**

Building Authority acquires and arranges for construction on property acquired by the City when bond sales are required.

---

**Deer Management Advisory Committee**

**To fill seven (7) vacant 1-year terms ending 12/31/2021**

The Rochester Hills Deer Management Advisory Committee was created on February 9, 2009 to review the Deer Management Policy enacted on September 29, 2008, and develop recommendations for inclusion or modification, if any; review vehicle/deer crash statistics and the annual deer count surveys to evaluate effectiveness of the controlled culling operation; gather and review metrics and data from all available sources and statistics for possible guidelines and inclusion in the Deer Management Policy; investigate and recommend any potential funding sources for implementation of the Deer Management Policy.

---

**Elections Commission**

**To fill two (2) vacant 3-year terms ending December 31, 2023**

Established by the Rochester Hills City Charter, Section 9.4, the Commission is responsible for all activities and duties required of it by State Election Law and City Charter relating to the conduct of elections in the City. The Commission is comprised of Clerk as Chairperson and two (2) qualified registered electors.

---

**Green Space Advisory Board**

**To fill three (3) vacant 3-year terms ending December 31, 2023**

The City of Rochester Hills Green Space Advisory Board (GSAB) was established by the City Council on October 19, 2005 for the purpose of developing strategies and recommendations to City Council regarding the expenditure of millage funds to permanently preserve natural green spaces, wildlife habitats and scenic views; protect woodlands, wetlands, rivers and streams; and expand the Clinton River Greenway and other trail corridors.

**Historic Districts Commission**

**To fill two (2) vacant 3-year terms ending December 31, 2023**

Established by Chapter 118, Historic Preservation, of the Code of Ordinances of the City of Rochester Hills pursuant to State of Michigan Public Act 169 of 1970, the Historic Districts Commission (HDC) investigates requests for establishing or changing Historic Districts, approves or disapproves plans for work on resources within Historic Districts and maintains a list of potential districts.

---

**Historic Districts Study Committee**

**To fill three (3) vacant 2-year terms ending December 31, 2023**

Established by City Council pursuant to Chapter 118, Historic Preservation, of the Code of Ordinances of the City of Rochester Hills, Oakland County, Michigan. The Historic Districts Study Committee serves as a standing committee to conduct duties as prescribed in the Ordinance.

---

**Human Resources Technical Review Committee**

**To fill two (2) vacant 1-year terms ending December 31, 2021**

The Rochester Hills Human Resources Technical Review Committee was created on November 29, 2006 to attend to the requirements of City Council's Policy for Salaries of Department Directors and Mayor, and Per Diem Fees for City Boards and Commissions and City Council's Policy for Review of Performance Appraisals for City Council Appointed Department Directors.

## **Liquor License Technical Review Committee**

### **To fill two (2) vacant 1-year terms ending December 31, 2021**

On February 10, 2014, City Council voted to re-establish the Rochester Hills Liquor License Technical Review Committee to review and make recommendations on annual inspections to be made of each Class C License operating within the City pursuant to Chapter 6, Article 1, Section 6-1 of the Code of Ordinances of the City of Rochester Hills, and license and permits, Chapter 6, Article II, including new license application requests, dance and/or entertainment permit requests, and establish a process for transfers of licenses.

---

## **Public Safety and Infrastructure Technical Review Committee**

### **To fill seven (7) vacant 1-year terms ending December 31, 2021**

The Rochester Hills Police and Road Funding Technical Review Committee was created on February 25, 2008. On April 26, 2014, City Council voted to change the name to Public Safety and Infrastructure Technical Review Committee. The committee is charged with analyzing public safety and infrastructure funding.

---

## **Rochester Hills Museum Foundation**

### **To fill two (2) vacant 2-year terms ending December 31, 2022**

It is the purpose of the organization to promote and assist in the development of the Museum's educational activities and programs and include the development of broad public, private and volunteer support, identifying and make grant applications, and assist in museum fundraising efforts. Therefore, it is important that the Museum Board of Directors be a diverse group who has an interest or experience in historic preservation, philanthropy or fundraising, and educational programming.

## **Trailways Commission**

### **To fill two (2) vacant 4-year terms (one representative and one alternate) ending December 31, 2024**

Paint Creek Trailways Commission operates and maintains the Paint Creek Trailway, which passes through the four Commission Communities of Oakland Township, Orion Township, Rochester and Rochester Hills.

## **Water System Advisory Council**

### **To fill seven (7) vacant 1-year terms ending December 31, 2021**

The Rochester Hills Water and Sewer Technical Review Committee was created on November 29, 2006 to review water and sewer rates on an annual basis and provide a recommendation to City Council. On Monday, November 12, 2018, per City Council approval, the Water and Sewer Technical Review Committee became the Water System Advisory Council. Its purpose shall include the following: To improve transparency in our community by advising and assisting with the creation of materials and plans to educate our community about the dangers of lead in drinking water.
