- * Paragraph A.2.b. will reflect "less than 10 acres".
- * Paragraph C.2.b. will contain the word "trail" after Paint Creek and Clinton River.
- * Paragraph A.2. and B.2. will contain the word "does" at the beginning of the sentence.

* Steep Slopes will become paragraph D.4.

- * Size of Property will become paragraph D.5.
- * Paragraph A.3. will include "no" as a option.
- * Zero points will be added to questions where needed to reflect consistency throughout the document

Member Robinson will incorporate the above mentioned final changes into the document which will be presented to City Council at their May 17, 2006 meeting for their consideration.

The Board discussed the Property Interest Acquisition Process and made final changes that included the following:

- * Paragraph 1. will reflect "numerous parcels" instead of referring to a specific number of parcels.
- * The word "acquisition" will replace the word "purchase" where appropriate in the document.
- * A timeline will be added to include an "informational session" with qualified speakers to inform interested property owners of various options approximately 30 days or more prior to nominations being accepted by GSAB. An Information Session will become paragraph 3.
- * Paragraph 5 will reflect the Clerk's Office as the contact for property owners to be placed on the GSAB agenda.
- * Paragraph 6 will reflect the development of target parcels for further review instead of target tiers.
- * The word "multiple" will be deleted from paragraph 3.
- * Paragraph 3 will become paragraph 4 and other paragraphs will be renumbered accordingly.
- * A sentence will be added to the new paragraph 8 that states "if favorably inclined a low or no cost option would be obtained". Paragraph 8 will also specify that a state

certified appraiser will be utilized for appraisals.

The members discussed the process in which the GSAB would come before City Council to seek approval for funds to perform appraisals on potential parcels that meet the Evaluation Criteria. The Board will make a final report to City Council recommending a property to acquire based on assessments, negotiations, closed sessions, and public hearings, etc. Two new paragraphs, 9 and 10 will explain GSAB's final recommendation and final report to City Council.

Chairperson Carvey and Mr. Hartner will incorporate the final changes into the document which will be presented to City Council at their May 17, 2006 meeting for their consideration.

A motion was made by Funk, seconded by Wallace, that this matter be Recommended for Approval to the City Council Regular Meeting.
