SUBJECT: Green Space Advisory Board (GSAB) recommendation

City Council at its meeting October 19, 2005 adopted Resolution RES0340-2005 establishing the Green Space Advisory Board along with the initial application process of the Board. Subsequently at the November 2nd meeting, Council established the GSAB Candidate Selection Committee to review the applications and make a recommendation to City Council.

The Clerk's Office received candidate questionnaires from twenty-one (21) residents indicating an interest in serving. The Selection Committee met and thoroughly reviewed all the application information looking for a good representative cross section of the communality focusing on attributes, past experience, and skills.

Although the selection was difficult because all applicants were well-qualified and brought different strengths and areas of expertise to the table, the Selection Committee is **highly recommending** the following seven individuals to serve on the GSAB:

Pursuant to the resolution adopted by Council establishing the GSAB, the seven (7) voting members shall be residents of the City of Rochester Hills and be appointed by City Council to three-year terms except for the initial appointments which will be staggered; four (4) members will be appointed to two-year terms and three (3) members to three-year terms, resulting in subsequent appointments occurring in alternate years. Therefore, for this initial appointment, Council will also need to determine which members will serve two-year terms and which will serve three-year terms.
