
In particular, I have served Rochester Hills in leadership capacities with the Friends of the Clinton River Trail, two church committees, two millage campaigns as well as the Green Space Advisory Board. In all of these I have tried to be a constructive, team-consensus builder moving the group toward common public service goals.

After being active in Rochester Hills Green Space millage campaigns in 2004 and 2005, I was appointed as a citizen representative on the first Green Space advisory board. In this capacity I have played an active role in representing taxpayer interest in the responsible use of tax dollars as well as the public's desire to preserve our rare green space areas (which was expressed through the 2005 millage passage). After working on both campaigns I felt an obligation both to see the initiative through it's execution through green space acquisitions as well as the fiscal responsibility to make sure that the money was well spent.
