SUBJECT: Hamlin Road Construction Project, (Hamlin Ct. to Dequindre Road)

### **REQUEST:**

It is requested that City Council authorize a Contract/Blanket Purchase Order between the Michigan Department of Transportation (MDOT) and the City of Rochester Hills for the Hamlin Road Construction Project (Hamlin Ct. to Dequindre Rd.) in the amount of \$2,866,050.00, and authorizes the Mayor and City Clerk to execute the agreement on behalf of the City.

#### **REASON FOR PURCHASE:**

Rochester Hills submitted a federal road funding request in 2011 for the repaving of Hamlin Road between Hamlin Court and Dequindre and was subsequently approved for construction phase funding for 2015. The funding category was under the Surface Transportation Program 3R category (Restoration, Resurfacing, Rehabilitation) and this program only funds 50% of requested construction costs for contractor payments. The approved amount of federal assistance back in 2011 totaled \$1,769,000.00. This amount, plus a 25% maximum allowable contingency, equals the total available grant funding of \$2,211,250.00 that is referenced in the attached agreement from the Michigan Department of Transportation (MDOT).

The funding agreement is dated April 15, 2015 and was prepared based on an estimated project total construction cost of \$5,077,300.00. Although the capped amount of \$2,211,250.00 will not change, the expense that Rochester Hills will owe is subject to change based on the actual bid amount.

City Council is being asked to approve this funding agreement in order to commence the construction phase as soon as possible to keep the project on schedule. However, since the low bid opened at the May 1 bid letting was higher than the original cost estimate, a revised funding agreement will likely need to be brought forward for City Council consideration.

#### **BUDGET:**

Funding is included in the 2015 Adopted Budget as MR-02B, MR-55, PW-02B, LS-10, and WS-02B. At this time, it is anticipated to cover the project overage for project MR-02B, with project surpluses in projects PW-02B & MR-55 (are projects funded through the Major Road Fund).

As project costs change with a revised funding agreement, a revised project financing plan will be presented.
