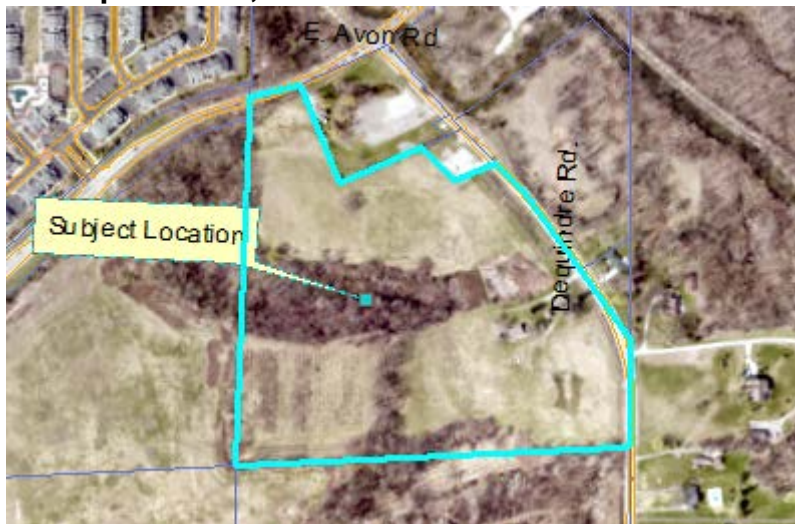
**NOTICE OF PUBLIC HEARING**
