COUNCIL AND YOUTH COMMITTEE REPORTS

Rochester Hills Government Youth Council

President Deel introduced **Caroline Bull**, Rochester Hills Government Youth Council (RHGYC) Representative.

Ms. Bull, a tenth grader at Rochester Adams High School, stated this is her second year serving on the RHGYC and she also sits on the Diversity and Equity Board for Rochester Hills. She shared that the RHGYC passed out water to participants of the Brookside Way Run that took place on September 26th. She announced the RHGYC is continuing to work with Human Resources to help them in their efforts to recruit part-time seasonal workers. She added the next RHGYC meeting will be on October 6, 2021.

Older Persons' Commission (OPC)

Mr. Walker announced there will be a Flu Shot and COVID Clinic held on Friday, October 15th from 9:00 a.m. - 1:00 p.m. in the OPC Auditorium. He encouraged those interested to call 800-848-5533 to schedule an appointment.

Rochester-Avon Recreation Authority (RARA)

Paul Davis, Deputy Public Services Director/City Engineer, explained this request is for a blanket purchase order for engineering design services for a public parking lot on the south side of Auburn Road by Eastern Road, as well as design services for creating a plaza located at the section on Eastern Road between Southerly Alley and Auburn Road.

Ms. Mungioli inquired about the plaza that includes furniture that will need to be maintained. She added parking was the intention for this area and is needed in this area. She questioned the cost of the plaza and how many parking spots will

be lost due to the plaza. She stated due to her concerns she is opposed to creating a plaza in this area.

Mr. Davis responded that there needs to be a safe way to get people from this parking lot to Auburn Road. He explained that the Planning Department and Department of Public Services (DPS) felt the plaza would be a nice amenity to this area. He added they could look into quotes with and without the plaza to get options on how to create a connection from the parking lot to Auburn Road.

Sara Roediger, Planning & Economic Development Director, shared these properties were brought to the City from private property owners that wanted to team up with the City to make this vision a reality. She added the first suggestion was to close Eastern Road at this location to make a large parking lot. However, the Fire Department was not comfortable with that suggestion. She stated the focus then shifted to the area between Auburn Road and the Alley, however, this area is so small the maximum parking spaces they could get were three spaces. She mentioned that in the next five to ten years there are plans for redevelopment in this area; therefore, in the interim there needs to be a safe way to get people from the parking lot to Auburn Road. She pointed out that the plaza walkway was a good compromise that is consistent with the streetscape on Auburn Road.

Ms. Mungoli stated she will support a sidewalk, and requested pricing options for just a sidewalk and the sidewalk with the plaza.

Vice President Bowyer stated she thought the road was going to be closed and now it is being proposed as a one-way street. She asked what determined the one-way in and not a one-way out, because residents that live near there might have concerns about people cutting through their neighborhoods. She added she likes the idea of a sidewalk connecting parking to Auburn Road; however, she is concerned about the cost of adding something temporary until this area is redeveloped. She also requested a quote with and without the plaza to see the difference in pricing.

Mr. Davis responded a one-way in would be better served and further explained that options were explored to construct sidewalks on both sides of the road but it was not possible due to an existing parking lot on the east side of Eastern Road. He added people that want to go north on Auburn Road can use the alley to head north. He mentioned they can provide different price quotes, however, the majority of the cost of this project will be spent constructing the parking lot.

Mr. Blair shared he is in favor of closing down part of the road. He added that he fully supports at looking for options for the sidewalk. He stated he would not be in favor of a semi-permanent fixture that could cost a substantial amount of money.

Mr. Hetrick concurred with Vice President Bowyer's request for options for this strip of property.

Ms. Mungoli stated she would like to amend the motion to add "options for connecting paths", to allow Council to look at different options for this strip of

property, whether it be just a sidewalk or a plaza with furniture. She mentioned she would like to look at other options and does not want to commit to a plaza tonight.

A motion was made by Mungioli, seconded by Bowyer, that this matter be Adopted as Amended by Resolution adding "options for connecting paths" to the Resolution. The motion carried by the following vote:

LEGISLATIVE & ADMINISTRATIVE COMMENTS

Mr. Walker announced Jayne Hamada recently celebrated her 100th Birthday and he was honored to present to her a proclamation on behalf of the City.

He mentioned the Butler Road project on the Consent Agenda is a unique scenario, stating Mr. Schneck gave him more insight on the project and the partnership with Auburn Hills. He commended Mr. Davis who took lead on this project and for doing a great job.

Vice President Bowyer thanked the residents that spoke tonight regarding Green Space and mentioned the Green Space Advisory Board is doing a great job at evaluating properties. She added Green Space is very important to her and she encouraged residents to nominate properties that they are considering selling.

She thanked the Paint Creek Trailways Commission for honoring her for her years of service on the Commission. She added there was a ribbon cutting for the bridge on the trail and at the same time a ceremony honoring the five Commissioners that were on the Commission during the bridge development.

Mayor Barnett thanked the residents that came to speak about the Green Space in their neighborhood. He stated he understands their passion for Green Space and will continue to work with residents in advancing Green Space areas throughout the City. He gave the following updates:

- He shared the City is continuing to work with DTE regarding the multiple outages in the City. Tom Talbert from his office is continuing to gather data to find out specifically where the outages are happening. He mentioned he had a meeting with the government relations representative and regional representative from DTE to talk about specific issues in the City. He added he sat in on a countywide call last week with all sixty communities speaking about the challenges with DTE. He pointed out that it is effecting a lot of residents and is a significant issue, therefore, he has created a task force that is specifically working on getting DTE to work quicker with the City.

- He stated the Brookside Way Run was yesterday and it was a great event, he also thanked DPS for their assistance in executing the event.
- He recognized a significant part of history in the City, the Haven House, stating a historic recognition was put together this past weekend for the family. He added this home started as a private 39,000 square foot home belonging to the Scinnick Family, then became a hospital and important part of the City.
- He pointed out that Innovation Hills Playground Grand Opening was extremely popular, adding the playground has produced an estimated four to five thousand people visiting daily on the weekends and two to three thousand people during the week. He stated the Community is excited and thanked Council and residents and non-residents for their support.
- He shared that Mr. Walker joined him at the OPC Senior Picnic where they helped serve food to the hundreds of seniors that attended.
- He announced that due to the weather the Sunoco pipeline construction work that will temporarily close Livernois Road south of Auburn Road has been rescheduled for this Wednesday, September 29, 2021 and the road will reopen on October 20, 2021. There is a detour route for this closure.
- He stated the City has employed a company called RedZone that will be capturing footage of the sewer system throughout the City to allow our DPS team to get a closer look at the system.
- He mentioned that the Rochester Community School District was ranked in the top ten school districts out of 550 districts.
- He announced the Pinnacle Awards will be held Friday, October 8, 2021, adding several Rochester Hills businesses and individuals have been nominated.
- He exclaimed Rochester Hills was honored with the Michigan Municipal League's 2021 Community Excellence Award (CEA) on September 24, 2021 during the League's annual Convention in Grand Rapids. He stated there were several awesome projects submitted from all over Michigan, however, the Auburn Road Corridor Project ultimately received the CEA.

President Deel commended and congratulated the City on winning "Project of the Year" in the State of Michigan.

Joe Snyder, Chief Financial Officer, summarized the budget process explaining the Proposed 2022 City of Rochester Hill's Budget was presented to Council on August 16, 2021, the Budget Workshop took place on August 23, 2021, and the Public Hearing was held on September 13, 2021. He added any Council questions received were noted, responses were given by the respective Director, and the question and answer document was included in the meeting packet. He requested formal approval of the City's Fiscal Year 2022 Budget Plan.

President Deel commended Mr. Snyder for his hard work each year with the budget stating the process is an important part of the budget. He added he is extremely proud of each department and thanked them for their hard work and preparation and time spent on this budget.

Ms. Morita stated this is her last budget approval and quoted Mark Tisdell "this is the most important thing we do all year", stressing that Council has to pay attention to the budget and ask questions because they are stewards of the City's tax dollars.

Whereas, subsequent to the City Council's review and comments, the Mayor adjusted the original proposed budget; and

Resolved, the following list of funds sets forth the general appropriations for the City and adopts the following City Budgets for Fiscal Year 2022.

Be It Further Resolved, the Mayor is hereby authorized to administratively adjust the operating budget line items up to \$25,000 per event, but in no case may total expenditures of a particular fund exceed that which is appropriated by the City Council without a budget amendment. Adjustments from capital accounts and fund balances shall be made only by further action of the City Council.
