## **PUBLIC COMMENT**

**Lee Zendel**, 1575 Dutton, responded to a letter written in the *Eccentric* newspaper stating that the residents are fortunate that the economic crisis has not affected emergency response in the City. He commented that the deer culling would provide food for people in need.

**Giuliana Deaconu**, 3190 Fallen Oaks Court, spoke against the deer culling. She questioned the number of deer to be culled and the cost that would be incurred.

**Martha Black**, 2408 Jackson Drive, commented that the deer issue is a motorist issue. She compared the statistics from deer/vehicle accidents to alcohol related accidents in the City of Rochester Hills.

**President Hooper** thanked the Rochester Hills Government Youth Council (RHGYC) for their participation in the 2008 Rochester Hometown Christmas Parade.

**Mr. Ambrozaitis** reported the following:

- He congratulated Cody Wilson, a student athlete at Rochester Adams High School, who was named to the All State Dream Team in football, and Megan Goethals, a student athlete at Rochester High School, for winning the Footlocker Cross Country Championship Midwest Regional in Kenosha, Wisconsin
- He congratulated Rochester Adams High School for its silver medal ranking in U.S. News and World Report of Best High Schools
- He reminded residents to wear reflective clothing for easier motorist visibility when exercising and walking pets
- He thanked Clerk Leslie for the election education classes that are televised on the City's cable channel

**Mr. Pixley** thanked the residents for sharing their opinions during the Public Comment portion of the City Council Meeting. He commented on the RHGYC's participation in the Hometown Christmas Parade as well as Holiday Family Fun Night at City Hall. **Derek Delacourt**, Deputy Director of Planning, introduced Deborah Odette, Field Representative from the Michigan Historic Preservation Network to give a brief presentation on the State of Michigan Certified Local Government Program. He stated that the Ordinance Amendment covers several housekeeping items, as well as two structural changes to the City's Preservation Ordinance, to conform with the State of Michigan's Historic Preservation Office requirements for local government certification.

**Deborah Odette**, Michigan Historic Preservation Network, described the following benefits for a city having Certified Local Government (CLG) status:

- The program is funded through the National Park Service and funds local grants in the amount upwards of \$800,000 through the State Historic Preservation Offices located in 50 states throughout the country
- Ten percent or \$80,000 of these funds must be subgranted to CLGs throughout Michigan annually
- The scope of the projects to be funded are broader than your typical preservation grant including: feasibility and market studies; planning grants; educational outreach such as brochures; and videos and exhibits highlighting the community's historical preservation assets
- Monies may be used to fund rehabilitation and restoration work, such as bricks and mortar work, foundations, roofs and interior design normally not subject to grant funding
- Currently the State of Michigan has approximately 19 CLGs that the City would compete with for funding

- These monies could be used to conduct intensive archaeological studies of its historic preservations
- Funding is granted on a 60/40 match basis, reimbursement basis, and is awarded annually
- CLG status strengthens a working relationship with the Michigan Historic Preservation Network for grant proposal processes and gives access to federal programs and offices which are part of the Historic Preservation Office, such as the Main Street Program, National Trust for Historic Preservation, Preservation Action Committee and Preserve America effort through the White House.

**Mr. Delacourt** added that the City has worked closely with the State Historic Preservation Office putting together a package to obtain CLG status that would benefit the City's Museum and programs.

**Public Comment:**

**Brian Dunphy**, 1610 Fair Oak, Vice Chair of the Historic Districts Commission and Vice President of the Rochester Avon Historical Society, stated his support of the Ordinance Amendment and explained the City should take advantage of the same funding that other Michigan communities have benefitted from. He referred to the list of needs Mr. Pat McKay, Supervisor of the Museum, set forth on his letter included in the packet for this Ordinance Amendment. He stated that the CLG certification would provide the funding necessary for the City to help maintain its historic character which is valued by the residents.

**Council Discussion:**

It was the consensus of Council to postpone this item pending clarification from City Attorney Staran on the following points:

- Concern about change in the section of the City's Ordinance that currently allows the City's Building Department to appeal a denial for raising a historically designated structure within the City directly to City Council. This process takes the City out of conformance with the State Historic Preservation Office's requirement for CLG certification. The change in the Ordinance would then direct appeals directly to the State Historic Preservation Office.
- The City's liability resulting from the recommendation to tear down or raze a dangerous building being denied.
- Clarification of Public Act 169; if the amendments to the Ordinance were not approved, would the fact that the City would not be in compliance prevent obtaining CLG status.

**John Dziurman, AIA**, member of both the Historic Districts Commission (HDC) and the Historic Districts Study Committee (HDSC), with over 20 years experience regarding these type of issues, explained that the first process in saving a building or preventing a dangerous building situation, is to stabilize the building by the mothballing process. He stated both groups work very closely with the City's Building Department for the prevention of dangerous buildings that would otherwise need to be demolished. He commented that in the past 20 years two buildings underwent the mothball process.

Responding to Mr. Hooper's request, **Mr. Delacourt** highlighted the following changes in the proposed Ordinance:

- Section 118-26 Redefines some definitions to bring the City in conformance with the definitions of the State Act
- Section 118-64 Primarily housekeeping revisions
- Section 118-129 Initial determination investigation regarding any new or proposed Historic Districts. Currently the Historic District Study Committee (HDSC) keeps a potential list which they prioritize, conduct studies, and bring the reports from those studies to Council to determine whether or not to designate a property as historic. The change would require the HDSC to come before Council to request a motion to initiate each one of those individual studies.

Council discussed the pros and cons of maintaining a standing Study Committee, with a current list of approximately 22 properties to study, or creating an Ad Hoc Committee for each specific request that came forward.

**Mr. Delacourt** stated that City Council has budgeted \$5,000 per year for a consultant to work with the Historic Districts Commission to conduct the necessary research. This amount is budgeted whether a standing committee or an ad hoc committee were in place. He explained that the HDSC specifically studies properties for either designation or delisting, or modifications to boundaries on existing projects. He noted that having a standing committee organizes the process for project submittal to City Council.

**Melinda Hill**, 1481 Mill Race Road, spoke in support of the retention of a standing committee to preserve the historical memory as time moves on and properties age and qualify as potential historical designations.

**Roger Rouse**, Director of DPS/Engineering, provided an overview of the vehicle replacements according to the City's Vehicle Replacement Policy:

- Eight Vehicles will be purchased through the Oakland County Cooperative Purchase Program. Thus, costs will be considerably less than retail pricing.

- Disposition of fully depreciated vehicles is conducted through the Michigan Intergovernmental Trade Network on-line auctions.

**Mr. Yalamanchi** inquired why the City does not approach the local vehicle dealers for a similar discount vehicle-purchasing program.

**Mr. Rosen** clarified that fleet governmental purchase agreements are an attractive contract opportunity available to all dealerships and surmised that the local dealerships would rather have the warranty work on these purchases. He stated that the benefit to the local dealers is that they would not lose profit in selling the vehicles at a discount but would retain the service and warranty work performed on the vehicles.

**Mr. Ambrozaitis** expressed his concern about low mileage vehicles being sold at auction and inquired why some of the vehicles could not be retained and serviced for one more year.

**Mr. Rousse** clarified that those vehicles replace older, higher mileage vehicles in other areas of the City's Motor Pool; the high mileage vehicles are then sent to auction while the low mileage vehicles are still retained in the City's Vehicle Fleet or in the Motor Pool. He explained that the increased costs of replacing batteries, exhaust systems and tires to maintain vehicles that are six to seven years old, having approximately 40,000 miles or more, can be more expensive than replacing them. He stated that if the vehicles are disposed of through the auction during that mileage period, the City benefits from a higher resale value without the additional maintenance investment.

**Ron Crowell**, Fire Chief/Emergency Management Director, gave a brief explanation of the three vehicles to be replaced: two (1993 and 1994) are utility vehicles and one (2000) is the public education van. He stated that Red Holman Pontiac has held the pricing for these 2009 vehicles, including the vehicles in Legislative File Number 2008-0606, at the 2008 pricing providing City Council approves the purchase before the 2008-year end.

**Mr. Ambrozaitis** expressed his support for purchasing the two utility vehicles, but felt that the replacement for the public education van should be revisited.

He further explained that it is a visible education tool at schools and in and around the community.

**Mr. Rosen** expressed his opinion that the pricing for the Acadia is historical and will never be offered again.

**Mr. Pixley** agreed that the pricing for the Acadia was phenomenal and supports the purchase of this vehicle.

**President Hooper** discussed his participation in the Sound the Alarm campaign which used the public education van. He explained that he could see the need for Ms. Butty to have more interior capacity than a compact car taking into account the large amount of educational materials she needs to have stored in the vehicle.
