**SUBJECT:** Accident and Sickness Insurance for Firefighter IAFF 3472 Population

## **REQUEST:**

Request for Purchase Authorization for Accident and Sickness Insurance for Firefighters in the amount not-to-exceed \$68,382.00 for three years; Volunteer Firemen's Insurance Service (VFIS), Baltimore, MD.

#### **REASON FOR PURCHASE:**

Under the terms of the Union Contract, the City funds the full cost of the accident and sickness insurance for their firefighter population. The new policy will cover 35 career members and 80 paid-on-call members.

Request for Proposals were solicited and evaluated. Emergency Services Insurance Agency/Volunteer Firemen's Insurance Services (VFIS) was selected as providing the best value for the City. The VFIS proposal exceeds the existing plan design and satisfies Union contract requirements at an annual rate \$3,944 less than the current rate. The new policy contains medical expense benefit improvements. Other proposals reviewed would reduce the maximum level of weekly income benefit from the current contract level.

The annual premium for Emergency Services Insurance Agency/Volunteer Firemen's Insurance Services (VFIS) underwritten by National Union Fire Insurance Company of Pittsburgh, Pennsylvania is \$22,794 yearly based on a 3-year contract totaling \$68,382.00.
