hereinafter referred to as the BOARD, and the City of Roch	heste	r Hills, he	ereinafter refe	erred to as
ROCHESTER HILLS, provides as follows:				

WHEREAS, the BOARD, ROCHESTER HILLS, and in cooperation with the City of Rochester, hereinafter referred to as ROCHESTER, have programmed the preliminary engineering for the gravel road paving of Washington Road located along the border of ROCHESTER and ROCHESTER HILLS, as described in Exhibit "A", attached hereto, and made a part hereof, which improvements involve roads under the jurisdiction of the BOARD, which improvements are hereinafter referred to as the DESIGN; and

WHEREAS, the estimated total cost of the DESIGN is \$170,000 and

WHEREAS, a portion of said DESIGN involves certain designated and approved funding in accordance with the Tri-Party Program, in the amount of \$85,000 for ROCHESTER'S share of the PROJECT, and in the amount of \$85,000 for ROCHESTER HILLS' share of the PROJECT, which amounts shall be paid through equal contributions by the BOARD, the Oakland County Board of Commissioners, hereinafter referred to a the COUNTY, ROCHESTER and ROCHESTER HILLS, respectively; and

WHEREAS, the parties hereto have reached a mutual understanding regarding the cost sharing of the DESIGN and wish to commit that understanding to writing in this Agreement.

NOW, THEREFORE, in consideration of the mutual covenants set forth herein and in conformity with applicable law, it is hereby agreed between ROCHESTER, ROCHESTER HILLS, and the BOARD that:

- ROCHESTER, ROCHESTER HILLS, and the BOARD approve of the DESIGN, declare its public necessity, and authorize the BOARD to perform or cause to be performed, and complete the DESIGN along with all administration in reference thereto.
- The cost of the DESIGN shall be funded in accordance with the following:
 - a. Tri-Party Program funds in the estimated amount of \$85,000.
 - b. The BOARD shall administer the payments towards the DESIGN cost for the COUNTY'S Tri-Party contribution of \$28,333, together with the BOARD'S Tri-Party contribution in an amount equal thereto.
 - c. ROCHESTER HILLS may use the accumulations of annual Tri-Party Program allotments to offset any overages, up to and inclusive of the 2007 Tri-Party Program, if necessary.
- Upon execution of this Agreement, the BOARD shall submit an invoice to ROCHESTER HILLS for \$14,167 (being 50% of ROCHESTER HILLS' share of the estimated total DESIGN cost).
- 4. Upon completion of the DESIGN work, the BOARD shall determine the total actual DESIGN cost and submit an invoice to ROCHESTER HILLS for the remainder of ROCHESTER HILLS' share of the actual total DESIGN cost.
- 5. Upon receipt of said invoice, ROCHESTER HILLS shall pay to the BOARD the full amount thereof, within thirty (30) days of such receipt.
- 6. The BOARD shall execute a separate Cost Participation Agreement with ROCHESTER for their share of the estimated total PROJECT cost.
