SUBJECT: Increase to Blanket Purchase Order for Citywide Printing Services

#### **REQUEST:**

City Council is requested to authorize an increase to the blanket purchase order for Citywide Printing Services in the amount of \$10,000 for a new not-to-exceed amount of \$122,650 through May 31, 2024 to Image Printing, Inc., of Royal Oak, Michigan.

#### **REASON FOR PURCHASE:**

The City requires the purchase of citywide printing services including but not limited to newsletters including the Hills Herald, other booklets, inserts, brochures, and letterhead. In March 2021, a Request for Proposal was solicited on MITN and competitive proposals were received and evaluated. Image Printing, Inc. of Royal Oak, MI was selected as the vendor providing the best value given their experience and quality of work for the citywide printing services. Earlier this year, City Council approved the renewal year agreement with Image Printing, Inc. in the amount not to exceed \$112,650.

On July 10, 2023 the Rochester Hills City Council approved the Ballot Language for the Special Police Millage I and Special Police Millage II Renewal and Combination to be placed on the November 7, 2023 General Election Ballot. City Council also approved and appropriation of up to \$25,000 for resident educational materials (a mailer) related to the Special Police Millage renewal, primarily to provide for the printing and postage of the educational mailer. The \$25,000 appropriation was allocated as \$10,000 for printing services and \$15,000 for postage.
