General responsibilities of the assistants will be setting up and securing racks, loading and plugging in product, assisting with continuity check and failed electric match checks and resolving any problems which can be resolved before shooting display, checking for unexploded materials after the display is shot and disassembling equipment, loading it back on the truck and cleaning the shoot site.
