> This past Saturday, July 22nd, a meeting held at City Hall to

> discuss millage renewals and pathways was one of the items
 > discussed. Based on discussion with City Council, the
 > consensus appears to be to go for a 10-year renewal of the
 > current millage, which would result in a request of
 > approximately 0.185 mil per year. Due to headlee rollbacks,
 > the renewal is not the original 0.20 mills.
 >
 > One of the requested items was to obtain consensus/support
 > from the existing ad-hoc pathway committee members for a full
 > millage renewal. Paul Davis and I met with you back in
 > January and we preliminarily discussed renewing the existing
 > 10-year and I believe everyone was in agreement that a full
 > 10-year millage renewal should be sought.
 >
 > Since time is of the essence to have the Ad-hoc Pathway
 > Committee recommendation to City Council as soon as possible
 > to allow for millage language to appear on November ballot,
 > we are requesting that you respond via email regarding
 > whether you are in support of a full 10-year millage
 > renewal. If you have any questions please let me know.
