Subject: Review of Fifth Reimbursement Request, Legacy Rochester Hills, LRH Development LLC,

Northeast Corner of Hamlin and Adams Roads, Rochester Hills (ASTI Project No. 9675-21)

As requested by the City of Rochester Hills Brownfield Redevelopment Authority (RHBRA), ASTI has reviewed the documentation provided regarding the fifth reimbursement request from LRH Development LLC, (the Developer) for the project located at the northeast corner of Hamlin and Adams Roads. The project includes two parcels, 15-29-101-022 (Parcel A) and 15-29-101-023 (Parcel B), which are considered the Eligible Property. The following documents provided the basis for this review:

- 1. The Brownfield Plan dated April 9, 2018
- 2. The Reimbursement Agreement, dated April 23, 2018
- 3. The 381 Work Plan, dated June 14, 2018
- 4. Amendment #1 to the 381 Work Plan, dated June 3, 2021
- 5. A letter dated August 28, 2024 from Arthur Siegal at Taft (Taft Letter).
- 6. A letter undated from Robert Borst at HM Environmental Services (HM Letter)
- 7. The Reimbursement Request prepared by AKT Peerless, cover letter dated October 31, 2024, and titled Legacy Rochester Hills, Reimbursement Request #5 for Eligible Activities, as amended (The Request)
- 8. LRH Jaske Invoice Hourly Tracker, dated December 9, 2024
- 9. Invoice #78503 from Mersino, dated 1/1/2021

The purpose of this review is to determine if the Request for the Eligible Property is in compliance with the approved Brownfield Plan, the Reimbursement Agreement, 1996 PA 381 (Act 381) at the time of the Brownfield Plan approval, the 381 Work Plan, the City's cost reimbursement procedures, and generally accepted practices.

This review includes the attached Table 1, which lists the Request by category and invoice, and Table 2 which summarizes amounts recommended and approved for reimbursement to date and provides the status of each category. Please note that costs were not allocated between Parcel A and Parcel B in this or previous requests, so a comparison of category budgets listed in the Brownfield Plan was not possible, and the amounts assigned to individual categories in Table 2 are estimates, based on the descriptions provided.

### **Background**

The Eligible Property is the subject of a Brownfield Plan dated April 7, 2018, and approved on April 23, 2018 (the Plan), a Reimbursement Agreement approved April 23, 2018, and a 381 Work Plan dated June 14, 2018, and approved on June 14, 2018.

The Plan estimated eligible costs with contingency to be \$9,619,587. Interest was estimated at an additional \$3,800,000, for a total estimated not-to-exceed reimbursement of \$13,419,587 (refer to first number column in Table 2). The Plan estimates that tax increment capture will continue for 21 years but will not exceed 24 years.

The 381 Work Plan requested \$9,619,586, including contingency, with \$4,581,988 in estimated interest, for a total estimated not-to-exceed reimbursement of \$14,201,574. EGLE approved \$8,336,996 with conditional approval of \$1,248,000 for the vapor mitigation tasks, for a possible total of \$9,584,996 before interest. However, the vapor mitigation system was not required and therefore a request for reimbursement for the conditional budget was not submitted to EGLE.

Based on discussions concerning funding the Parcel B operations and maintenance beyond the 30 year statutory limitation for tax capture (see memo of April 16, 2021), it was agreed that the amount for operation and maintenance for Parcel B would be reduced removing costs for years 25-30 (reduced from \$900,000 to \$756,000), and that the local brownfield revolving fund would be used to cover operation and maintenance costs beyond the 30 year period. This reduced the approved amount in the Brownfield Plan to \$9,475,587 (see second number column in Table 2) before interest. Because this change was made after approval of the Brownfield Plan and the original 381 Work Plan, it is not recorded in either document.

Amendment #1 to the 381 Work Plan, dated June 8, 2021, was provided by the City to EGLE on April 16, 2021, and approved by EGLE in a letter dated June 15, 2021. This amendment includes a Response Activities Plan for the Parcel B Slurry Wall installation. It also incorporated the change in Parcel B operation and maintenance assumptions but further reduced the unit costs for a final amount of \$576,000. In addition, it reallocated the remaining operation and maintenance assumptions and adjusted the amount allocated to each category based on experience with the clean-up to date, and reduced the amount of the contingency by allocating it to other tasks. This amendment reduced the requested eligible expenses costs to \$9,475,587 before interest (consistent with the modified Plan), and a total cost of \$14,057,575 with interest. Note that estimated interest costs in the 381 Work Plan and Amendment #1 to the 381 Work Plan went from \$3,800,000 in the Plan to \$4,581,988 in the amendment. Please also note that the final amended 381 Work Plan is dated June 8, 2021, after the submittal letter by the City, indicating that subsequent changes were made. The amended 381 Work Plan is calculated to require 23 years for reimbursement, including interest.

A summary of the various approved plans is provided below in Table 3, organized by task. Based on discussions to modify the Plan and the approval of Amendment #1, this review assumes that the **total amount available for reimbursement from local and school tax capture is \$9,475,587, not including interest**. Please note that the Reimbursement Agreement limits all environmental costs to \$14,201,575 based on an earlier version of the Plan.

Following the fourth request for reimbursement, the applicant submitted a request dated August 29, 2024 to review the escrow account payments that were recommended as ineligible in our review memo dated April 14, 2024, and denied by the RHBRA. A subsequent review of these expenses indicated that many of those invoices were for eligible costs incurred by the applicant but funded through the escrow account. Based on meetings with the applicant it was determined that some of these eligible costs would be reimbursed through the Plan using TIF while others would be reimbursed through the escrow account. This fifth request for reimbursement includes those previously denied invoices. Where applicable, payment through the escrow account is listed and those invoices are not eligible for reimbursement under the Brownfield Plan.

#### **Reimbursement Request**

This Request is for \$474,354.27 for eligible activities as described in the supporting documents and does not include a request for interest payment. The Request was submitted in an email dated October 31, 2024, from Jeremy McCallion of AKT Peerless with three subsequent supplemental documents provided.

The final Request included a summary table, copies of invoices being requested for reimbursement, waivers of lien, and cancelled checks. Based on the requested reimbursement, numerous categories listed in Table 2 are now over budget, but the total amount recommended for approval and paid does not exceed the approved amount in the Plan and 381 Work Plan (not including interest). For purposes of

this review, the categories have been combined into tasks, and a recommendation to allocate contingency to various tasks is provided below.

Based on the materials provided, the Request is recommended for approval with the following exceptions.

- 1. Reference Line 223: This was originally denied in the fourth request because of a lack of documentation about a \$70,000 settlement for the full invoice amount of \$297,147.64 for work on the slurry wall construction. An explanation of the settlement and a full unconditional waiver from Mersino, have now been provided. A total of \$255,905.06 in eligible activities are listed on this invoice, and since the settlement amount is less than the listed eligible activities, ASTI now recommends approval of the \$70,000 amount paid for this invoice. This category in the Brownfield Plan is over budget.
- 2. Reference Lines 229-272: Although these are listed as "ASTI" in the Request table, these requests are for reimbursement of payments to the City of Rochester Hills for City consultant services from 2017 to 2022. The check references provided are for payments into the City escrow account. These invoices were denied as part of the fourth request but based on subsequent review it was determined that these payments are for eligible activities, and are recommended for reimbursement under either the Plan or the escrow account, as indicated in the attached Table 1. This category is over budget in the Brownfield Plan. The following adjustments have also been made.
  - a. Reference Line 233: This is not an eligible activity because it is a review of parking lot options which were not included in the Plan, but is potentially eligible from local only taxes or the escrow account.
  - b. Reference Line 272: There is a slight discrepancy in the reimbursement requested. AKT Peerless requests \$498.24 but this invoice is listed at \$495.54 in the Administrative Summary attached to the Request. ASTI recommends reimbursing the listed amount of \$495.54, with the balance of \$2.70 being denied.
- Reference Line 273-294: Invoices from AKT Peerless, Jaske Construction Inc., and Taft Stettinius
   Hollister LLP TIF Compliance and Project Management are potentially eligible for reimbursement, however costs for Cost Tracking and Compliance are over budget.
- 4. Reference Line 330,331: Invoices from AKT Peerless for Temporary Site Control and Erosion Control are eligible for reimbursement but are over budget (\$50,000 Brownfield Plan, \$130,207.07 Requested).
- 5. Reference Line 332-350: The No Further Action and Due Care Plan categories are over budget.
- 6. Reference Line 356 516: Invoices from Jaske Construction Inc. are potentially eligible but are over the budget (\$47,000 Brownfield Plan, \$172,253.02 Requested). Please note the following adjustments.
  - a. Reference Line 400: Number inversion, Jakse Invoice Hourly tracker shows charge of \$469.09 while the invoice is for \$496.09, for a difference of \$27.00. Recommendation to reimburse \$469.09 until there is proof of cost.
  - Reference Line 401, 408: Both Invoices have a rounding error of one cent relative to the Jaske Invoice Hourly Tracker that is rectified in the reimbursement request.

Costs for Plan implementation exceed the EGLE limit of \$30,000 that was in effect at the time the Plan was approved. Please note that recent legislation increased the maximum to \$50,000, but this review assumes that the requirements at the time of Plan approval apply. Therefore, any amount above the applicable maximum can only be reimbursed from the proportional share of local tax capture. The cost to date for implementation is \$54,885. Under the old limit, reimbursement of \$24,885 would be limited to local tax capture.

#### **Reimbursement To Date**

Table 2 summarizes all requests for reimbursement to date in comparison to the eligible activity costs approved in both the Modified Plan and Amendment #1 to the 381 Work Plan. Please note that most categories are over budget, which was not a consideration in recommending approval for reimbursement, because the contingency was not previously required, and category scopes have changed and are estimates. As indicated below in Table 4, these categories can be combined into tasks to better manage the amount over budget. The RHBRA has the authority to approve expenses in amounts that vary from the task amounts listed in the Plan, up to the maximum approved in the Plan.

To date, including this memo, recommendations for reimbursement have totaled \$8,382,879.95 or 101% of the Modified Plan budget for eligible activities not including contingency (see Table 2 and above), or 88% of budget including contingency. However, because of the need to maintain the remaining budget for the Parcel B operation and maintenance (at \$726,436), the total requested reimbursement exceeds the approved amount in the Plan before the contingency. Therefore, this memo recommends reallocation of \$839,903 of the contingency to adjust task budgets as indicated below.

#### Recommendations

Based on the documents provided, the items that have been recommended for approval for reimbursement in this fifth request are in compliance with the approved Brownfield Plan, the Reimbursement Agreement, 1996 PA 381 (Act 381) at the time of the Brownfield Plan approval, the amended 381 Work Plan, the City's cost reimbursement procedures, and generally accepted practices. In addition, the total amount requested to date is within the approved total not-to-exceed amount including contingency (refer to Table 2). Therefore, **ASTI recommends approval of \$424,954.19 to be paid from local and school tax capture, and \$24,884.90 to be paid from the proportional share of local tax capture only** as indicated in Table 6, and reallocation of the contingency in the amount of \$839,903 to adjust task budgets as indicated in Table 5. Any adjustment to the task budgets must be approved by

the RHBRA prior to approval of this reimbursement request. A summary of the recommendation is provided below.

The RHBRA must consider the following items as part of the approval of the above reimbursement request.

- 1. The RHBRA must approve use of the contingency funds in the amount of \$839,903 to adjust task budgets, provided that the costs do not exceed the total reimbursement allowed by the Brownfield Plan.
- 2. The RHBRA must determine the adequacy of waivers and method of payments made to GCI Construction LLC rather than LRH Development LLC and Goldberg Companies as identified in the Plan.
- 3. The RHBRA must approve reimbursement from local taxes only for a payment of \$11,183.20 ( 44.9397% of \$24,884.900) for Brownfield Plan implementation in this fifth request. If not, then this amount is Ineligible for reimbursement.
  - a. All future requests for reimbursement for Plan implementation, including Cost Tracking and Compliance, will be for the proportional share of local taxes only.
- 4. The RHBRA must approve reimbursement to the applicant from local and school tax capture for eligible expenses in this fifth request in the amount of \$424,954.19.
- 5. The RHBRA must approve reimbursement to the applicant for eligible expenses funded under the escrow account in the amount of \$23,669.48.
- 6. The RHBRA must approve reimbursement to the applicant from local only capture or the escrow account for parking lot review, in the amount of \$816.00...
