SUBJECT: Increase to Blanket Purchase Order for Irrigation System Maintenance & Repair Services

#### **REQUEST:**

City Council is requested to authorize an increase to the blanket purchase order for Irrigation System Maintenance & Repair Services in the amount of \$35,000.00 for a new not-to-exceed amount of \$95,900.00 through December 31, 2024 to Techseven Company of Shelby Township, Michigan.

#### **REASON FOR PURCHASE:**

In 2022, the Procurement Division solicited competitively sealed proposals for Irrigation System Maintenance and Repair Services on the MITN website. Two proposal responses were received and evaluated by a committee comprised of Facilities and Purchasing staff. Award was recommended to Techseven Company as providing the best value, responsive, responsible proposal for the spring startups, winterizations and repairs as needed during the term of the contract. City Council approved the contract with Techseven Company in April 2022 for \$60,900.00 for three year term to expire December 31, 2024.

During the 2022 and 2023 irrigation seasons, the Facilities team completed the citywide irrigation startups with the Techseven Company and the contractor discovered numerous repairs that are essential to get the systems operating correctly. The reasons contributing to the repairs are curb hopping from vehicles, snowplowing, old or out of date materials, theft and vandalism. Due to the unanticipated extent of the damages to the irrigation systems, additional funds are needed and require Council approval.
