AMENDMENT TO PEDESTRIAN/BICYCLE PATHWAY, EASEMENT

On the 13th day of August 1991, Leader Dogs for the Blind, Inc., whose address is 1039 S. Rochester Road, Rochester Hills, Michigan 48307 granted an easement for a pedestrian/bicycle pathway favoring the city of Rochester Hills, Michigan, whose address is 1000 Rochester Hills Drive, Rochester Hills, Michigan 48309, as recorded on April 6, 1992 in Liber 12494, Pages 803 through 805, Oakland County Records (hereinafter referred to at the "Existing Easement"). The legal description of the original recorded easement is:

A 27-foot wide bike path easement across Lots 7, 8, 9, and 10 according to the plat of OAKLAND VIEW SUBDIVISION as recorded in Plat Liber 22, Page 2, Oakland County Records. The bike path pavement being described as being the north 27 feet of Lots 7, 8, 9, and 10.

Currently, Leader Dogs for the Blind is commencing construction of Phase 2 of a facility replacement project on the subject property. Portions of the existing pathway have been found to be outside the existing easement.

The city of Rochester Hills and Leader Dogs for the Blind wish to amend the legal description of the easement to describe its new location.

Based on the facts and circumstances, the parties agree to and by this document amend the existing easement so that the following legal description shall replace and supercede the legal description of the existing easement as originally recorded. The originally recorded legal description for the existing easement shall be of no further force or effect and the city of Rochester Hills, Michigan, shall have those same easement rights in the following described easement:

A 42-foot wide bike path easement across Lots 7, 8, 9, and 10 according to the plat of OAKLAND VIEW SUBDIVISION as recorded in Plat Liber 22, Page 2, Oakland County Records. The bike path pavement being described as being the north 42 feet of Lots 7, 8, 9, and 10.

In all other respects, the original easement is ratified confirmed, and redeclared. The recording of this document is exempt pursuant to MCLA 205.505 (a) and MCLA 207.526 9 (a).
