COUNCIL AND YOUTH COMMITTEE REPORTS

Rochester Hills Government Youth Council (RHGYC):

*President Tisdell introduced Hannah Kowalski, RHGYC Representative. He
noted that she is a Senior at International Academy and this is her fourth year*

on the RHGYC. He commented that Ms. Kowalski was very successful in the RHGYC's fund raising efforts to sell Carson's Community Sale coupon books.

Ms. Kowalski reported that RHGYC members recently partnered with the City's Fire Department to promote fire education events. She noted that RHGYC members were at the Village of Rochester Hills this evening working with Fire Department members; and she mentioned that members participated in a workshop day at the Fire Department to learn about the Department's duties and responsibilities. She commented that RHGYC members want to partner with other City Departments as well to learn their duties.

Deer Management Advisory Committee (DMAC):

Dr. Bowyer reported that through the cooperation of Allan Schneck, Director of DPS/Engineering, and DPS Staff, prismatic tape was added to the eight City-owned deer crossing signs in Rochester Hills. She stated that the tape's effectiveness will be studied to determine whether it helps illuminate the sign, encourage drivers to slow down, and reduce deer-vehicle collisions. She commented that once it is determined that the prismatic tape is effective, the City would be able to approach the County to inquire whether the tape be added to County-owned signs.

Rochester-Auburn Hills Community Coalition (RAHCC):

Vice President Morita announced that the RAHCC will host a seminar on October 17, 2016 at 7:00 p.m. at City Hall presented by Ken Krygel on how to recognize alcohol and drug abuse in teens. She noted that the seminar is free for everyone.

Older Persons' Commission (OPC):

Vice President Morita expressed her appreciation to President Tisdell for his participation in a benefit concert for the OPC Meals on Wheels program. She noted that the concert raised \$1,040.00 for the program.

Rochester Hills Museum Foundation:

Vice President Morita reported that the Museum Foundation Board Members asked for volunteers to help light pumpkins at the Stone Wall Pumpkin Festival held at the Rochester Hills Museum at Van Hoosen Farm last Saturday. She commented that she and her son, Drew, lit many pumpkins that evening.

Auburn Road Corridor Study:

Mr. Wiggins stated that he had the opportunity to attend the informational open house for the Auburn Road Corridor Study at the DPS Facility today, which reviewed the study with various neighborhood groups, business representatives and individuals who attended. He mentioned that 85 to 100 people stopped by. He commented that it is good to see so much resident input and encouraged anyone interested to submit their comments.

President Tisdell noted that the open house offered the residents an opportunity to speak with some of the designers regarding potential plans for the area.

Joe Snyder, Chief Financial Officer, reviewed the 3rd Quarter Budget Amendments, noting that Total Revenues are proposed to decrease by \$185,000; and Total Expenditures are proposed to decrease by \$457,000. He stated that the result is a net positive impact on Fund Balance of \$272,000.

He explained that the 3rd Quarter Budget Amendments are typically the lightest of the four quarter amendments, as its primary focus is on applying 2015 Interfund lookback charges. He noted that charges are allocated in 2015 based on budget estimates at that time; and once final numbers come in, these charges are trued-up to actual figures. He commented that the Amendment is mostly comprised of interdepartmental dollars moving around.

He mentioned that one new item contained in the Budget Amendments is the inclusion of funding for the Retiree Health Care Trust. He explained that per the most recent actuarial study, it was found that the Trust was 95 percent funded. He pointed out that some monies from the General Fund and from the Water and Sewer Fund was allocated in the Amendments to achieve 100 percent funding of the Trust.

Ed Anzek, Director of Planning and Economic Development, explained that Lear Corporation purchased Eagle Ottawa at the end of last year; and a transfer of the Tax Abatement to Lear Corporation will be necessary in order for the Abatement to continue. A Public Hearing is required prior to Council's consideration of the transfer. Ed Anzek, Director of Planning and Economic Development, noted that Council approved the preliminary phase for the 30-unit, 12.8 acre Bloomer Woods development at John R and Avon Roads in March. He explained that the project has received Engineering approval and is ready for approval of the Final Site Plan. He stated that the project came before the Planning Commission at the September 20, 2016 meeting, where it received a recommendation for approval. He pointed out that the project density is lower than what is allowed by the standards. He mentioned that Greg Windingland was in attendance to represent Lombardo Homes.

LEGISLATIVE & ADMINISTRATIVE COMMENTS

Mr. Hetrick encouraged anyone interested to attend the Rochester-Auburn Hills Community Coalition seminar next Monday presented by Ken Krygel on what is being faced by middle and high school students these days. He commented that he attended the Auburn Road Corridor Study open house this afternoon and was very impressed by the comments from residents and their suggestions on how to improve activity in that area.

Mr. Kubicina announced that the Rochester Area Youth Assistance will host a Halloween Spaghetti Dinner fund raiser on October 22, 2016 from 4:30 p.m. to 7:00 p.m. at the Rochester Fire Hall. He mentioned that October is Breast Cancer Awareness month.

Mayor Barnett announced the following:

- The Stone Wall Pumpkin Festival was held at the Rochester Hills Museum at Van Hoosen Farm this past weekend.
- PKSA Karate held a grand opening on Saturday. Their grand opening raised \$875 which they donated to the Rochester Hills Fire Department.
- A contest to rename Riverbend Park is ongoing during the month of October. The City is seeking a new name for the park, as there are eight parks in close proximity in various communities with similar names, leading to confusion. The winner of the contest will receive a bicycle donated by KLM Fitness. A video highlighted contest information.
- Paint the Plow will once again engage area students to show their school spirit and decorate the City's snow plowing fleet. This year, the City of Rochester will also participate in the event with their fleet. Designs must be submitted by November 4, 2016.
- The DPS Department has wrapped up a significant number of road projects this year, and several staff members have retired. Thanks go to the DPS team for their exceptionally hard work this year.
- A new promotional video, premiering at the Rochester Hills night held at Jimmy John's Stadium, was highlighted.

President Tisdell thanked Vice President Morita for acknowledging the Older Persons' Commission (OPC) Meals on Wheels program. He mentioned that the program serves 140,000 meals each year and maintains no waiting list. He commented that any resident or family member in need can contact the OPC.

Vice President Morita reported that City Council and the Planning Commission held a joint meeting last week.

Mr. Brown noted that today is Columbus Day, a national holiday. Veteran's Day is November 11, 2016.

City Clerk Tina Barton announced that Tuesday, October 11, 2016 is the deadline for registering to vote for the November 8, 2016 Presidential Election. She mentioned that anyone with a college student or any voter who mailed in their registration or did not register in person should know that they will not be

eligible for an absentee ballot unless they appear before the Clerk's Office or any Secretary of State to be personally identified before the election. She noted that the Secretary of State has a Michigan Voter Information Center available on the web, where voters can make sure that they are registered, are able to track their absentee ballots, or view sample ballots. She mentioned that Rochester Hills ballots are also available for review on the City's website. She stated that the Clerk's Office received its reimbursement for the March primary expenses in the amount of \$72,000. She expressed appreciation to her staff members for closely accounting for all expenses related to the election, leading to the reimbursement.

Paul Davis, City Engineer/Deputy Director of DPS, explained that two items before Council approximately six months ago included proceeding to schedule a Public Hearing regarding the possible vacation of Helmand and Castell Roads. He explained that there was much controversy, regarding the road vacation, and the item was dropped with no intention of bringing it back. He mentioned that associated with that item and also dropped at that time was a request to vacate a 25-foot existing right-of-way for S. Castell Avenue south of Helmand Road. He commented that this right-of-way exists only on paper and the City has no intentions of ever developing that road. He pointed out that the Sanctuary development borders the property on one side, and Helmand on the other. He stated that this item would set a public hearing for October 24, 2016 on that road vacation.

President Tisdell questioned whether there was any gravel or other evidence of roadway.

Mr. Davis responded that there was not, and pointed out that the area is treed. He displayed aerial photographs showing the area adjacent to two homes.

Public Comment:

Jeffrey Miller, 501 S. Castell, noted that he and George Snow, the other property owner adjacent to the undeveloped road, were in attendance to support the road vacation. He pointed out that the road is very close to his front door. He stated that his house was built back in the early 1900s.

Mr. Davis mentioned that the road is adjacent to a plat recorded in 1896, but not included the plat. He commented that this is the time to vacate the property.

Dr. Bowyer questioned what will happen to the land that is vacated.

Mr. Davis responded that he consulted with John Staran, City Attorney, who noted that typically, one-half of the property is vacated to each adjacent property owner. He stated that 12-1/2 feet would go to each property owner in this case.

Paul Davis, City Engineer/Deputy Director of DPS, stated that the Administration is trying to move forward in the event that a Blanket Purchase Order is needed to accomplish some upcoming work in the Jenoptik site on Hamlin Road. He explained that the City has a standing Blanket Purchase Order for \$200,000 to utilize for emergency work, and approximately \$127,000 has been and was intended to be spent, including work done to create the emergency connection required between Rochester Hills and Auburn Hills. He mentioned that once crews got into the project for the emergency connection and saw the conditions it was determined that the project was beyond the City crew's capabilities, and one of the approved contractors, Pamar, was used at a cost of approximately \$86,000. He commented that it is thought that some upcoming work will exceed the Blanket amount, and the Administration is trying to be proactive to extend the Blanket Purchase Order. He stated that the work, which will include getting into Hamlin Road, will be bid this week; and he noted that with the season ending soon it would allow the project to get started.

President Tisdell commented that this is a part of the City's commitment to help Jenoptik meet its tight schedule for its expansion upon their purchase of the City's land on Hamlin Road.

Mr. Hetrick stated that the two bidders currently approved for the emergency work are potential bidders for these other activities.

Mr. Davis responded that approving the request tonight would increase the Blanket Purchase Order and make a greater amount available for the two contractors. He commented that it is possible that another bidder would be the lowest recommended bidder for the project; and he explained that should that occur, the Blanket Purchase Order would not be utilized and the item brought back to Council for approval.

Mr. Hetrick commented that if that were the case, the increase could be removed in a future Budget Amendment.

Mr. Davis responded that this could occur. He commented that the work is expected to be in the range of \$100,000.

A motion was made by Hetrick, seconded by Brown, that this matter be Adopted by Resolution. The motion carried by the following vote:

Resolved, that the Rochester Hills City Council hereby authorizes an increase to the shared Blanket Purchase Order for underground utility repairs and related services to Pamar Enterprise, Inc., New Haven, Michigan and Superior Excavating, Auburn Hills, Michigan in the amount of \$100,000.00 for a new not-to-exceed amount of \$300,000.00 through December 31, 2017.

Mayor Barnett stated that the Administration is constantly looking at ways to promote Rochester Hills throughout the community and the region. He distributed coffee mugs imprinted with the City's logo to Council, noting that they are a promotional tool.
