Re: OPC and RARA Millages

Dear Ms. Hill:

As directed by the City Council, I have prepared and enclose proposed ballot questions for the renewal of the Rochester-Avon Recreation Authority (RARA) and the renewal and additional millage for the Older Persons Commission (OPC). The RARA ballot proposal is a straightforward renewal of the present millage that includes authorization to levy through this year. Thus, the renewal millage will begin levies in 2006.

Because the OPC ballot proposal includes a renewal and an additional millage request, the proposal is slightly more involved. The General Property Tax Act, at MCL 211.24f(5), provides that a municipality may only propose a joint-single question requesting both the renewal of a voter authorized millage and the authorization of a new additional millage if the additional millage is less than 0.5 mill. As the additional millage request is for 0.0676 mills, the City may place both the renewal and new additional millage request in the same ballot question. The present OPC millage expired with the levy in 2004. This necessitates the ballot proposal to request the levy to begin this year.

In order to finalize the ballot proposals, I need the City's assistance in coming up with the amount of the first year millage (to be inserted in the last line of each proposal) if the millage is authorized and levied in full.

BALLOT QUESTION

Older Persons Commission (OPC) Millage Renewal Plus Additional Millage

(Pursuant to MCL 211.24f(5), the city is authorized to submit a single question asking for the renewal of a millage and an additional millage so long as the additional millage is not greater than 0.5 mills. The 1995 ballot approved 0.0245 mills. which has been reduced by Headle to the present OPC millage of 0.0224 mills. The OPC would like to increase the total millage to 0.09 mills. As the difference of these two is .0676 mills, the city may pursuant to the statute, request for a renewal of the present millage and additional .0676 mills in one ballot question.)

Proposal

Shall the City of Rochester Hills renew and continue to levy 0.0224 mills (\$0.0224 per \$1,000 (reduced by the Headlee Amendment from the original 0.0245 mills) and also levy a negadditional 0.0676 mills (\$0.0676 per \$1,000) for a total of 0.09 mills (\$0.09 per \$1,000) provide funds to the Older Persons Commission to enable it to maintain or increase handicapper and senior transportation services, on the taxable value of all property assessed for taxes in the City for ten (10) years, beginning in 2005 and continuing through 2015, inclusive, which will provide an estimated revenue of \$\\$ if levied in full in the first year of such levy?
