**SUBJECT:** No Haz Program

**REQUEST:**

City Council is requested to authorize the 2012 Oakland County Household Hazardous Waste (No Haz) Inter-Local Agreement between Oakland County and the City of Rochester Hills in the amount not-to-exceed \$40,000.00.

**REASON FOR PURCHASE:**

In 2011, Oakland County continued its coordination and agreement with the consortium of eight (8) communities to provide a comprehensive household hazardous waste collection program. The amount approved by City Council for the program in 2011 was \$50,000. The end cost of the collection events for Rochester Hills was \$39,651.54. There has been a 15% overall reduction in participation in the program.

The reduction in participation can be attributed to the effectiveness of the program. Now entering the ninth year of No Haz, it appears that the "stockpile" of household hazardous materials has subsided to a yearly manageable amount for homeowners. Despite the reduced participation in the program, Rochester Hills continues to account for the largest share of homeowner involvement with 41% of the total attendance.

In 2011, there were three (3) No Haz collection events. Three (3) events are also planned for 2012. The request for \$40,000 for 2012, includes the estimated proceeds from a \$10.00 per vehicle charge to residents.
