Location(s) of Concern:

Neighborhood location is between Walton Blvd. and Tienken, Squirrel Road and Firewood/Falcon.

What specific concerns have you identified for the above locations?

Traffic speeds, high traffic volume, and lack of signage coupled with limited site distances in a winding, hilly neighborhood have has put pedestrians and children in danger

- 1. Traffic Speeds are a concern.
- 2. Limited Site Distances put children and homeowners at risk.
- 3. Inclines require slower and careful attention for the safety of residents more so than a straight street with no sight limitations.
- 4. Streets with tight curves (often with greater than 90 degree turn) with no signage to slow drivers.
- 5. Increased traffic due to drivers using neighborhood streets to cut through.
- 6. Danger for children using neighborhood parks

Please identify the specific days and or time periods the traffic problem takes place.

A majority of the concerns expressed by the residents of Hunters Creek subdivision are not tied to a time of day. The winding, hilly roads in our neighborhood are dangerous for residents and children at all times.

Increased traffic and speed violations for those using the neighborhood as a cut through from Tienken to Walton Blvd., as well as, residential speeders could be tied to morning and evening rush hour during the week.

In addition, younger drivers who speed through the neighborhood often do so around 3:00 p.m. when school let's out. On the weekends, traffic violations occur at all times of day.

What solutions do you feel would address your concerns?

Signage, Pavement Markings, Enforcement and Neighborhood Traffic Safety Campaign and possibly the Resident Speed Reduction Program – depending on neighborhood acceptance. See further detail to possible solutions below:

Recommended Actions for the City based on the individual feedback (below)


- 1. There currently are only two Stop signs in the subdivision. They are located at the following intersections:
 - -- Firewood and RoseBrier Street
 - -- Firewood and Plum Ridge

Recommend replacing All Yield signs with Stop sign within the subdivision.

- 2. All 90 degree (or greater) curves "SLOW" markings on pavement, "SLOW" signs or "Children At Play" signs, or limited visibility cautions. In addition, special attention at curves with three way intersections.
- 3. Police presence in neighborhood not just streets outside of sub
- 4. Slow / Children Playing signage near neighborhood parks
- 5. Limited parking on streets
