SUBJECT: Supplemental Sickness & Accident Policy for Firefighters

REQUEST:

Approval of a total of \$55,292 is requested to pay an adjusted balance of \$1815.67 for the 2006 Volunteer Firemen's Insurance Services, Inc. (VFIS) policy premium for 2006, as well as \$26,738 per year for 2007 and 2008 to pay the remaining premiums for the three-year policy.

REASON FOR PURCHASE:

The VFIS policy provides duty-related life and disability benefits to paid-on-call and full-time fire fighters. Council originally authorized a three-year blanket purchase order in May 2006. However, the amount approved was \$24,918, which is a single installment of the three-year policy renewal. The number of covered employees has also been adjusted to comply with the current union contract and to extend coverage to the Fire Chief and Deputy Fire Chief based on their risk of injury or death at a fire scene. As a result, the underwriters have adjusted the premiums from \$24,918 to \$26,738 per year. Although the City may terminate the policy prior to term, a three-year renewal was chosen based on lower yearly premium costs over single year renewals.

VFIS is identified in the current union contract as the supplemental work-related disability insurance carrier for the union. However, premium costs have risen over 34% during the past five years and management has identified the carrier issue in the upcoming Act 312 arbitration with the union.
