**REQUEST:**

The Department of Public Services (DPS) recommends the Rochester Hills City Council commit to the Michigan Department of Transportation (MDOT) Transportation Alternatives Program (TAP) matching funds necessary to construct a pathway on the east side of Rochester Road (M-150) between Michelson and Nawakwa Roads, including non-motorized pathway and crosswalk improvements on the M-150 bridge over M-59 and further authorize the Mayor to execute any documents necessary to complete the grant application.

**REASON FOR PURCHASE:**

The City of Rochester Hills is applying for a Michigan Department of Transportation (MDOT) Transportation Alternatives Program (TAP) grant to fund the M-150 Non-Motorized Connectivity Project. This project will construct a new pathway on the east side of M-150 between Michelson and Nawakwa Roads and includes non-motorized improvements to the M-150 bridge over M-59. The initiative is a key component of the city's Master Transportation Plan, as it closes a significant gap in the non-motorized transportation system. Furthermore, the project will improve pedestrian access over M-59, increase the use of the SMART regional bus system, and enhance connectivity to major state-wide trail systems, including the Paint Creek Trail and the Clinton River Trail.

The total estimated cost for the project is \$1,795,956. The City is requesting \$1,436,765 from the TAP grant, which would cover 80% of the cost. The City of Rochester Hills will commit to funding the remaining 20%, amounting to \$359,191, from the Major Roads Fund. In addition to the matching funds, the City may be responsible for grant reporting requirements, permits, administration, potential cost overruns, and any non-participating items. Approval of this resolution will authorize the Mayor to proceed with the grant application and affirms the City's commitment to owning, operating, and maintaining the new pathway.
