## COUNCIL AND YOUTH COMMITTEE REPORTS

### Rochester Hills Government Youth Council (RHGYC):

**President Deel** introduced **Hannah Bennett**, Rochester Hills Government Youth Council (RHGYC) Representative.

**Ms. Bennett** stated that this is her fourth year on the RHGYC. She shared that at their November meeting the RHGYC decorated ornaments for the Rainbow Connection Foundation which were delivered to the Foundation last Thursday, December 3, 2020. She noted that this month the RHGYC is working with the New Day Foundation's Hope for the Holiday Project; they have adopted three (3) families that they will be providing gifts for. She announced that the next RHGYC meeting will be held on January 6, 2021.

### Southeast Michigan Council of Governments (SEMCOG):

**Mr. Hetrick** stated that he attended the SEMCOG Executive Meeting last week. He reported that SEMCOG received their Certification from the Federal Government for their Planning Process which will give them access to federal grants related to transportation type initiatives. He pointed out that the City can apply for that federal grant money as it becomes available for projects that would qualify.

## PRESENTATIONS

2020-0535 Legislative Update presented by State Representative Michael Webber

**State Representative Michael Webber** stated that due to term limits, this will be his last legislative update for City Council. He stated that he has enjoyed serving the residents of the City of Rochester Hills and working with the elected officials on various issues throughout the last six (6) years. He reported that COVID-19 will be the focus of the lame duck session, and provided the following updates:

- HB 6207 is expected to pass with strong bipartisan support later this week and that will extend the ability to have these virtual Council meetings for another three (3) months through March 31, 2021.
- Negotiations are ongoing with Governor Whitmer's proposed \$100 million Supplemental Budget. He explained that due to the lack of movement at the Federal level, there is a push to do something at the State level to support small businesses, healthcare workers, and to extend unemployment benefits.
- He proposed legislation to exclude the sales and use tax on Personal Protection Equipment (PPE), citing that was a necessary expense that no one saw coming when they were putting their budgets together for 2020.

- The Legislature is working with the Administration to obtain the metrics being used to determine whether a business can reopen or not. He stated there is concern for both the businesses, as well as the employees, on a short- and long-term. He noted that the school districts, through the Return to Learn Plan, have different metrics that they are putting into place working with the local county health departments for transparency on how the decisions are being made.
- HB 6440 will be voted on this week. He stated there has been concern over the amount of money jurisdictions have to spend to publish notices in the newspaper when more and more people are getting their information via the web. He noted that there has been push back from the Michigan Press Association and others.
- The Storm Water Bill package will be taken back up by another Representative in January 2021.

**President Deel** thanked Representative Webber for his many years of service, both locally and at the State level. He pointed out that he has always been a responsive, helpful resource and expressed his appreciation for the leadership and service he has provided.

**Vice-President Bowyer** thanked Representative Webber for his service and for all that he has done for the residents.

**Mr. Hetrick** extended his appreciation for Representative Webber's service to the City of Rochester Hills and to the greater Rochester Area.

**2020-0529** Presentation of New City Website; Kevin Krajewski, Information Systems Director, Presenter

**Kevin Krajewski**, Information Systems Director, introduced, and stated they are here to give an update on the City's website redesign project. He stated he is very proud of the work his staff members, specifically Margaret Casey and Sarah Olson, have done on this project.

**Tom Talbert**, Strategic Innovations Specialist, stated if there was ever a time for a website redesign it is now. He stated he is pleased to report on the first significant redesign to rochesterhills.org in eight (8) years. He pointed out that changes have been made to the website functionality and accessibility. He explained that MIS began the migration from the old website to this new website on November 19, 2020. He noted that since that time, they have been working on a few refinements. He congratulated Margaret Casey and Sarah Olson on the great job they have done.

Mr. Talbert introduced **Sarah Olson**, Information Systems Administrator I, and stated she will be providing Council with some highlights of the website.

**Ms. Olson** stated the focus of the redesign was to make a website that was

modern, responsive and resident-focused. She highlighted the differences between the old and new website. She also pointed out that the website will look the same whether you log in on a mobile phone, a tablet or a PC. She explained the work that was done on the navigation system was to optimize resident focus, in addition to the search field and links to social platforms. The website can also be translated in over 70 different languages, and noted that it is a one-stop shop for everything our residents may be looking for.

**Council Discussion:**

**President Deel** stated the new website is an absolute change for the better. He congratulated Mr. Krajewski and his entire team for doing their homework on this project. He stated the website is much easier to navigate, is visually appealing, and has a consistent theme with other elements throughout the City.

**Mr. Blair** stated he really likes the new interface and pointed out that he noticed that all of the information that was on the old website has not been populated on this new website. He encouraged promoting the new website on the City's social media platforms.

**Ms. Olson** explained that they are still in the process of working with some departments to populate their information on the website.

**Ms. Mungoli** thanked the entire MIS team for all of their work on the new website. She stated the payment process for water bills and such is much more user-friendly.

**Vice-President Bowyer** also congratulated the MIS team for the work they did on the new website.

**Sara Roediger**, Planning & Economic Development Director, and **Kristen Kapelanski**, Planning Manager, were present to address the proposed amendments.

**Ms. Kapelanski** explained that both the Planning staff and the Planning Commission have been working on several Zoning Ordinance amendments over the past several months. The amendments proposed this evening include requiring on-site signage for PUD requests, to require five-foot concrete sidewalks on roads with a right-of-way of less than 120 feet, to require average lot widths equal to the minimum lot width for the lot size variation option, to clarify when an accessory structure is considered attached, to remove parking lot double striping standards, and to require street trees on private roads.

**Vice-President Bowyer** stated that she sits on the Planning Commission and the changes being proposed to this Ordinance are mostly housekeeping changes and for easier readability.

**Sara Roediger**, Planning & Economic Development Director, and **Kristen Kapelanski**, Planning Manager, were present to address the proposed amendments.

**Ms. Kapelanski** stated that these proposed changes will address multiple family parking and were made in conjunction with the City's Planning consultant, Giffels Webster, as well as the Planning Commission. She explained that one multiple family parking standard will apply to multiple family and FB-multiple family developments, and visitor parking will be increased to 0.25 visitor spaces per unit for all types of units. She further explained that spaces located within garages, carports or driveways cannot be counted towards visitor spaces. She mentioned that they have also done some cleanup on tandem parking space regulations.

**Vice-President Bowyer** stated that she sits on the Planning Commission and the Planning Commissioners have noted that there has not been enough parking for visitors and wanted to correct that for future developments.

**Kristen Kapelanski**, Planning Manager, stated this request is for a 60,000 square foot medical office that will employ approximately 60 people. She noted that this site is zoned O-1 which does permit medical offices and the applicant has indicated that the facility is geared mainly toward outpatient procedures and surgeries. She shared that the Planning Commission has approved the revised plans that the applicant has submitted, along with the natural features setback modification and the tree removal permit. She stated that the Planning Commission has also recommended approval of the Wetland Use Permit. She explained that ASTI is recommending approval of the Wetland Use Permit noting that the wetland to be impacted is of low ecological value.

**Vice-President Bowyer** shared that this is a nice development that is going to go on South Boulevard. She explained that the Wetland Permit is for approximately .33 of an acre and is not impinging on a lot of that area.

Findings:

1. Of the .33 acre of wetland area on site, the applicant is proposing to impact approximately .33 acre.
2. The wetland area is of low ecological quality and is only a semi-valuable natural resource, so the City's Wetland consultant, ASTI, recommends approval.

Conditions:

1. If required, that the applicant receives an applicable EGLE Part 303 Permit prior to issuance of a Land Improvement Permit.

***Kristen Kapelanski***, Planning Manager, stated that this request is for the development of a 16-unit condo to be developed on the north side of Avon, east of Rochester Rd. using the MR Mixed Residential Overlay. She explained that this overlay allows some flexibility in design in order to protect natural features and allow for the creation of site amenities for some active open space, which the applicant has included. She stated that the Preliminary Site Condo was approved on September 14, 2020 by City Council with a few conditions that have all been addressed. She noted that the Planning Commission has recommended approval of the Final Site Condo Plan at their November meeting.

Ms. Kapelanski introduced **Mark Gesuale** and **Jim Polyzois** with Cambridge

Knoll, and **Ralph Nunez** of Nunez Design.

### **Council Discussion**

**President Deel** questioned if the issue with the neighbor on the other side of Avon Road has been resolved to everyone's satisfaction.

**Ms. Kapelanski** responded that the applicant has been working very closely with the neighbor and has proposed planting 10 to 12 giant arborvitae which grow eight to 10 feet high. She explained that these arborvitae should screen the oncoming headlights as much as possible. She noted that staff is satisfied with that solution.

**Mr. Nunez**, Landscape Architect, stated that he has been working closely with **Sara Roediger**, Planning & Economic Development Director, who has been the contact person with the neighbor. He noted that they have come up with multiple concepts plans for the neighbor to choose from for the shading of oncoming headlights. He explained that the giant arborvitae are the fastest growing arborvitae and will grow up to five feet per season if properly watered and maintained. He mentioned that the neighbor has also requested additional screening closer to her house because some of the lights will continue to hit her home from cars traveling on Avon and they have agreed to alter two (2) of the large evergreen trees and place a hedge row of five (5) to six (6) plantings along the front at her discretion.

**Ms. Roediger** stated she has been working to facilitate an acceptable agreement between the neighbor and the applicant. She shared that they are still finalizing the details but the applicant has been very accommodating in trying to find reasonable solutions to address the issue. She stated she is confident they will come to an appropriate and agreeable solution.

**Vice-President Bowyer** thanked Ms. Roediger, Mr. Nunez and Mr. Polyzois for working with all of the neighbors surrounding the development. She acknowledged that the developers have agreed to put in more plantings to provide more privacy for all of the neighbors.

**Sara Roediger**, Planning & Economic Development Director, stated that City Council held a Special Meeting on June 1st to consider approving resolutions for temporary relaxation of regulations association with outdoor dining/seating standards, outdoor use regulations, and temporary sign standards for the City's business community in response to the COVID pandemic. She noted that those resolutions had a sunset date of December 31, 2020 and pointed out that due to the fact that we are still in the midst of the COVID pandemic, she is requesting an extension of these items through June 1, 2021. She explained that she has been working with the Building Department, the Fire Department and the Department of Public Services to ensure that any type of temporary operation is reviewed and vetted through staff.

**Ms. Morita** stated that local business owners realize how important extending these regulations are to the success of their businesses. She shared that she spoke to a local restaurant owner earlier today and was happy to be able to tell him that they would be considering extending the outdoor seating at least through June 2021.

**President Deel** shared that he had a similar conversation with a local business owner. He extended his appreciation to the Planning & Economic Development Department and the Building Department for looking for ways to accommodate local businesses; and to the business owners for being flexible during this time with the COVID pandemic.

**Ms. Mungoli** questioned why the extension only goes through June, rather than September. She requested a periodic update of those businesses applying for these permits.

**Scott Cope**, Building/Ordinance/Facilities Director, responded that there have been between 12 to 15 COVID Special Permits issued to date. He noted that there has been more recent interest expressed and are currently in the process of speaking to several business owners. He stated that there have been between 200 to 300 temporary signs installed throughout the business community for advertisement. He addressed question of the extension going through June versus September by stating that he would be fine with either.

**Ms. Mungoli** noted that when they discussed this item back in June, she questioned the effectiveness of the signs, their placement and which sign belonged to which business. She stated that she really has not seen that improve.

**City Attorney John Staran** clarified that these resolutions temporarily relax the Ordinances the City has in place. He explained that it has been the City's practice to not go out more than three (3) to six (6) months without actually amending the Ordinance. He noted that the primary reason these Ordinance requirements were relaxed in the first place was in response to the

*State-ordered restrictions on occupancy levels. He mentioned that it was the City's desire to help the local business owners. He pointed out that no one knows how long those types of occupancy restrictions are going to last and cautioned against getting too far out in front of the State and Federal authorities. He suggested that as June 2021 approaches and it looks like these resolutions should be extended, the City always has the ability to revisit that.*

4. Temporary outdoor dining/seating areas may include temporary structures, enclosures or covers with or without lighting or heating elements to protect patrons and staff from inclement weather. Such temporary structures and any lighting or heating elements will require permits and inspections to ensure safety;
5. Any establishment seeking to temporarily add or expand outdoor dining/seating areas pursuant to this Council Resolution must electronically submit a Special Event Permit application to the City's Building Department and include a plan for the proposed outdoor dining/seating area depicting the location of the outdoor dining/seating area and all tables, chairs, fixtures and furnishings with dimensions and distances clearly marked for

pedestrian paths and between seating.
