AN ORDINANCE TO AMEND SECTIONS 54-46, 54-151, 54-154, 54-156, 54-163, 54-192, 54-197, 54-226, 54-229, 54-234, 54-261, 54-262, 54-265, 54-270, 54-302, 54-319, 54-471, 54-590, 54-711, 54-742, 54-748, 54-776 AND 54-806, SECTION 54-193 REPEALED OF CHAPTER 54, FEES, OF THE CODE OF ORDINANCES OF THE CITY OF ROCHESTER HILLS, OAKLAND COUNTY, MICHIGAN, TO MODIFY FEES CHARGED FOR ROADSIDE STANDS, PERMITS, PLAN REVIEWS, FIRE SUPPRESSION, PRESSURE TESTING. PLUMBING LICENSES, ELECTRICAL SERVICE, CONTRACTOR REGISTRATION/LICENSE, FUEL BURNING EQUIPMENT, MECHANICAL LICENSES, SPORTS FIELD RENTAL, OTHER ACTIVITIES, SERVICE CALLS, PUBLIC HYDRANTS, TAP, MUNICIPAL WATER AND SANITARY SEWER CONNECTIONS, AND TO REPEAL CONFLICTING OR INCONSISTENT ORDINANCES.

#### THE CITY OF ROCHESTER HILLS ORDAINS:

<u>Section 1</u>. Section 54-46 of Chapter 54 of the Code of Ordinances of the City of Rochester Hills shall be amended as follows:

#### Sec. 54-46. Roadside stands, markets, and Christmas tree sales.

The fees for operating roadside stands, markets, and Christmas tree sales shall be as follows:

- (1) For a resident residing on the property and operating:
  - a. Roadside stand or market.....\$100.00
  - b. Tree sales ......100.00
  - c. Application fee......<del>50</del>75.00
  - d. No bond is required. Application fees shall be credited to the approved permit feeare nonrefundable.
- (2) All others:

  - b. Application fee......<u>5075</u>.00
  - c. The application fee shall be credited to the approved permit feeis nonrefundable.

<u>Section 2</u>. Section 54-151 of Chapter 54 of the Code of Ordinances of the City of Rochester Hills shall be amended as follows:

### Sec. 54-151. Permit fee schedule.

The fees for services and acts performed by the building department, including, but not by way of limitation, the issuance of building permits, examination of plans and specifications, inspection of construction undertaken pursuant to a building permit, issuance of certificates of use and occupancy, issuance of permits for demolition of and moving of buildings, charges for work started before a permit is obtained, special investigations, reinspections, etc., shall be paid as set forth in this article.

<u>Section 3</u>. Section 54-154 of Chapter 54 of the Code of Ordinances of the City of Rochester Hills shall be amended as follows:

### Sec. 54-154. Plan review fees.

- (a) The building permit fee shall be based on the total estimated cost of the project as computed from the current International Code Council (ICC) Building Valuation Data Report, exclusive of site work. Plan review fees shall be as follows:
  - (1) R-3 and U plan review shall be computed at 0.00147 of the estimated construction cost or \$75.00, minimum. This fee covers two reviews: the initial review and one re-review. A fee of \$75.00 per hour will be charged for additional reviews.
  - (2) All others shall be computed as follows:
    - a. Zero dollars to \$1,250,000.00 shall be computed at 0.00222 of the estimated construction cost or \$150.00 minimum.
    - b. Over \$1,250,000.00 shall be computed at 0.00074 of the estimated construction cost plus the first \$1,250,000.00 at 0.00222.

This fee covers two reviews: the initial review and one re-review. A fee of \$75.00 per hour will be charged for additional reviews.

- (b) For <u>Review of site plans associated with planning commission activities</u>, an escrow balance of \$150.00 shall be established and maintained, which shall be used to pay applicable fees shall be charged at \$75.00 per hour.
- (c) Where review of construction documents is performed by city employees other than building department employees, the review fee shall be charged at \$75.00 per hour.
- (d) Plan review of hazardous materials shall be charged at \$75.00 per hour.
- (e) Plan review for accessibility, energy, structural, mechanical, plumbing, electrical, and fire protection shall be charged at 15% of the building plan review fee or \$150.00 minimum. This fee covers two reviews: the initial review and one re-review. A fee of \$75.00 per hour will be charged for additional reviews.

- (f) Payment shall be in advance of the review based on estimated cost.
- (g) Where review of construction documents is performed by outside consultants, the review fee shall be charged at 1.5 times the actual cost. Payment shall be in advance of the review based on estimated cost.
- (h) High hazard occupancies (group H) will be charged an additional 25% of the calculated plan review fee.

<u>Section 4</u>. Section 54-156 of Chapter 54 of the Code of Ordinances of the City of Rochester Hills shall be amended as follows:

#### Sec. 54-156. Certificate of occupancy.

The fees for certificates of occupancy shall be as follows:

<u>Section 25</u>. <u>Severability</u>. This ordinance and each article, section, subsection, paragraph, subparagraph, part, provision, sentence, word and portion thereof are hereby declared to be severable, and if they or any of them are declared to be invalid or unenforceable for any reason by a court of competent jurisdiction, it is hereby provided that the remainder of this ordinance shall not be affected thereby.

Section 26. Repeal, Effective Date, Adoption.

(1) <u>Repeal</u>. All regulatory provisions contained in other City ordinances, which are inconsistent with the provisions of this ordinance, are hereby repealed.

(2) <u>Effective Date</u>. This ordinance shall become effective on \_\_\_\_\_, following its publication in the *Oakland Press* on \_\_\_\_\_, 2014.
