PURPOSE:

City Council is requested to authorize the Mayor to enter into the North Oakland County Household Hazardous Waste (No-Haz) 2004 Inter-local agreement between Oakland County and The City of Rochester Hills.

DISCUSSION:

Oakland County is continuing its coordination and facilitation in an agreement with North Oakland County communities in order to form a comprehensive household hazardous waste management program. This program is intended to provide consistent, reliable and convenient access to collection services for residents of northern Oakland County. This program will also assist in further reducing toxic materials from entering waterways and landfills. An educational program will also continue to inform residents about the disposal and reduction of these hazardous materials.

Residents from participating communities will have the opportunity to schedule appointments to drop off household hazardous waste at six (6) separate events scheduled during 2004. Each community will be billed separately for each event.

The County has reviewed and accepted a bid proposal from Environmental Technical Services (ERTS). Communities are now being requested to consider a commitment to this agreement.

It is staff's recommendation that City Council authorize the Mayor to enter into this agreement with Oakland County to participate in the No-Haz program for 2004.

An amount of \$55,000.00 was budgeted for this program in 2004.
