Mr. Moore, City Surveyor, provided a map indicating Priority I, II, and III. The major concern is how individuals approach easements and how land acquisitions are managed and secured.

Ordinance enforcement of past and future easements, buffers, conservation and setbacks was discussed. The Board discussed the following questions:

- * Should GSAB make recommendations of how to protect land.
- * Can and should millage money be used for monitoring purposes.
- * How is land permanently protected.

At the present time monitoring is done following a complaint received by the City. The GSAB scope is to recommend acquisition not monitor and protect land. Before purchasing land, these issues need to be explored and direction should be provided by the City. The Board will continue to seek discussions with the attorney. GSAB would like to develop a proposal to submit to City Council addressing the concerns.

Time Table for First Cycle for Property Interest Acquisition
