AGREEMENT FOR MAINTENANCE OF STORM WATER DETENTION SYSTEM

STORM WATER DETENTION SYSTEM
This agreement is made on Aug. 4, 03, by J-P Property Management L.L.C. ("J.P.")
whose address is 388 South Main St. Plymouth, MI 48170
and the CITY OF ROCHESTER HILLS (the City), whose address is 1000 Rochester Hills Drive,
Rochester Hills, MI 48309.
RECITALS:
WHEREAS,owns and contract the property described in
attached Exhibit A; and
WHEREAS, J.P. has, and the City has
approved, a storm water drainage and detention system (the system), which includes a detention
basin, for the property as described and depicted in <u>Exhibit A</u> ; and
WHEREAS, the parties will benefit from the proper use and maintenance of the System and
desire to enter into this agreement to provide for the same.
THEREFORE, the parties agree:
1. <u>Use of the System:</u> Components of the System, including the detention basin, shall be
used solely for the purpose of detaining storm and surface water on the property until such time
as: (i) The City may determine and advise, or, or
successors, grantees or assigns, in writing that it is no longer necessary to use the detention basin
to detain storm or surface water; and (ii) An adequate alternative for draining storm and surface
water has been provided which is acceptable to the City and which includes the granting of such
easements to the City or third parties for the alternative drainage system as may be necessary.
2. <u>Maintenance:</u>
Ashall be responsible for the proper maintenance,
repair and replacement of the System and any part thereof, including the detention basin.
B. Proper maintenance of the System shall include, but not limited to: (i) Keeping the bottom
of the detention basin free from silt and debris; (ii) Removing harmful algae; (iii) Maintaining steel
grating across the basin's inlets; (iv) Controlling the effects of erosion; and (v) Any other
maintenance that is reasonable and necessary in order to facilitate or accomplish the intended
function and purpose of the System.

3. Action by City:	In the event	J.P.	or
successors, grantees,	or assigns, negle	cts or fails at any time to	properly maintain the System or
any part thereof, the Ci	ity may notify	J.P.	or
successors, grantees o	or assigns, in writi	ng, and the notice shall in	clude a listing and description of
maintenance deficienci	ies and a demand	that they must be corre	cted within thirty (30) days. The
notice shall further spe	cify the date and	place for a hearing to be	held at least fourteen (14) days
after the date of the not	tice before the Cit	y Council, or such other t	poard or official to whom the City
Council may delegate re	esponsibility. At t	he hearing, the City Cour	ncil (or other board or official) may
endorse or modify the I	listing and descrip	otion of deficiencies to be	e corrected and, for good cause,
may extend the time wi	ithin which the de	ficiencies must be corre	cted.
Thereafter, if the ma	aintenance deficie	encies are not corrected	within the time allowed, the City
may undertake and mal	ke the necessary	corrections, and may ma	intain the System for a period not
to exceed one (1) year.	Such maintenan	ce of the System by the C	City shall not be deemed a taking
of the property, nor sha	all the City's action	ns be deemed to vest in	the public any right to use the
property. If the City det	ermines maintena	ance of the system by the	City should continue beyond one
year, the City shall hold	d, and provide ad	vance written notice of, a	a further hearing at which
J.P.	or	successors,	grantees or assigns, will not or
cannot properly mainta	in the System, th	e City may continue to m	naintain the System for another
year, and subject to a s	similar hearing an	d determination, in subs	equent years.
In the event the City	/ determines an e	mergency condition cau	sed by or relating to the System
threatens the public he	alth, safety or ger	neral welfare, the City sh	all have the right to immediately
and without notice ente	er the property an	d undertake appropriate	corrective action.
4. Charges: The Ci	ty shall charge to	the current owner of the p	property the cost of maintenance
or other corrective action	on undertaken by	the City in accordance v	vith this agreement, plus a ten
percent (10%) administ	rative fee. If not ti	imely paid, the City may a	assess the charges on the City=s
tax roll, which charges s	shall be a lien on t	he real property and shal	l be collectable and enforceable
in the same manner ge	neral property tax	kes are collected and ent	forced.
5. <u>Notice</u> : Any not	tices required und	der this agreement shall	be sent by certified mail to the
address for each party	set forth below, o	or to such other addresse	es as such party may notify the
other parties in writing:
